## State Water Resources Control Board

### **NOTICE OF TRANSMITTAL OF PROPOSED ORDER**

The State Water Resources Control Board  
Administrative Hearings Office  
held a public hearing regarding the pending petitions  
for extensions of time and petitions for change of

#### **Trimont Land Company and Northstar Community Services District**

for water-right Permits 15905, 15906, 16618, and 16619 (Applications A022822, A022823, A023851, and A023849), which authorize diversions and use of water from Unnamed Streams, Unnamed Springs, Sawmill Flat Springs, West Martis Creek and Martis Creek in Placer County.

On March 24, 2021, the Administrative Hearings Office (“AHO”) of the State Water Resources Control Board (“State Water Board” or “Board”) issued a Notice of Pre-Hearing Conference and Public Hearing in this proceeding. The applicable statutes, hearing issues and pre-hearing and hearing schedules are described in the March 24 notice.

On May 5, 2021, the AHO held the pre-hearing conference described in the March 24 notice. On August 6, October 27 and December 3, 2021, the AHO held the public hearing in this proceeding.

On April 1, 2022, the AHO issued a Notice of Draft Proposed Order, which released the AHO’s draft proposed order in this proceeding for review and comments by interested parties. This notice also directed Trimont Land Company (“Trimont”) and Northstar Community Services District (“Northstar CSD”) to make specified revisions to exhibit Trimont-Northstar 11 and to submit the revised exhibit to the AHO.

On May 2, 2022, Trimont and Northstar submitted exhibit Trimont-Northstar 11 (revised) to the AHO, and advised the AHO that they did not have any comments on the draft proposed order.

The AHO has prepared its June 14, 2022 proposed order and transmitted it to the Clerk of the Board. Copies of the AHO’s transmittal memorandum, proposed order, and Appendices A through D are enclosed. Also enclosed are files that show the changes from the April 1, 2022 draft proposed order to the June 14, 2022 proposed order and the changes from Appendices A through D to the April 1, 2022 draft proposed order to Appendices A through D to the June 14, 2022 proposed order.

As authorized by Water Code section 1114, subdivision (c)(4), any interested party may submit, **by July 13, 2022**, a written request to the Board that describes which of the actions in Water Code section 1114, subdivision (c)(2) the party requests the Board to take, including an explanation of the reasons for the party's request.

The actions in subdivision (c)(2) that the Board may take regarding the June 14, 2022 proposed order are: (A) adopt the proposed order; (B) make technical or minor changes to the proposed order and adopt it as the Board's order; (C) reject the proposed order and remand the case to the AHO for further proceedings; and (D) reject the proposed order and decide the case upon the record or upon an agreed statement of the parties, with or without taking additional evidence.

The AHO plans to ask the State Water Board to consider adopting this proposed order during the Board's July 19, 2022 meeting. The AHO will send parties to this hearing copies of the agenda of the Board meeting during which the Board will consider this proposed order, when the Clerk of the Board posts this agenda, which normally is 10

days before the meeting. The agenda will specify the process for appearing at the Board meeting to make oral comments.
