the City of Solvang

for water right Permit 15878 (Application A022423), which authorizes diversions of water from the Santa Ynez River (underflow) in Santa Barbara County.

BACKGROUND

On March 30, 2020, the Administrative Hearings Office (AHO) of the State Water Resources Control Board (State Water Board or Board) issued a Notice of Public Hearing and Pre-Hearing Conference Call regarding the petitions filed by the City of Solvang (Solvang) for change and extension of time for water-right Permit 15878 (Application 22423). The background facts, applicable statutes, hearing issues and previously proposed pre-hearing and hearing schedules are described in the March 30, 2020 notice and in the subsequent pre-hearing conference and status conference notices and orders.

As discussed in the October 2, 2020 Status Conference Order and Notice of New Status Conference, Solvang withdrew its petition for extension of time on August 7, 2020. This proceeding now concerns only Solvang's water-right change petition, as modified by Solvang on August 7, 2020, and protests to that petition.

On April 29, 2020, the AHO held a pre-hearing conference. The AHO held status conferences on: June 29, September 24, and November 6, 2020; March 26, July 22 and December 16, 2021; February 2 and August 30, 2022.

Between October 18, 2022, and February 14, 2023, the AHO hearing officer conducted mediation among Solvang, the National Marine Fisheries Service, California Trout, and the California Department of Fish and Wildlife. The AHO hearing officer reported in a February 14, 2023 Notice of Termination of Mediation that the mediation did not resolve any pending issues and representatives of the parties to the mediation did not sign any settlement agreement. To maintain the confidentiality of the mediation proceedings, the Presiding Hearing Officer re-assigned this matter to herself for the purpose of conducting a hearing and preparing a proposed order for the Board's consideration.

PRE-HEARING CONFERENCE

The AHO will hold a pre-hearing conference in this proceeding on the date and at the time listed on the first page of this notice. During this pre-hearing conference, the hearing officer will discuss the following issues with the parties' representatives:

- 1. When should the AHO conduct a hearing on Solvang's petition to change Permit 15878? When should the AHO conduct the rebuttal portion of the hearing? How many days of hearing should the hearing officer schedule for the case-in-chief portion of the hearing and the rebuttal portion of the hearing?
- 2. What time limits should the hearing officer impose on the presentation of oral summaries of witnesses' written testimony during the hearing? Should the hearing officer impose a time limit on cross-examination of witnesses? If so, what should that time limit be?

- 3. What deadlines should the hearing officer set for the parties to submit Notices of Intent to Appear (including witness lists), case-in-chief exhibits, and rebuttal exhibits?
- 4. Should the hearing officer set deadlines for the parties to submit written evidentiary objections in advance of the hearing?
- 5. Are there any other pre-hearing deadlines that the hearing officer should set?
- 6. When should the AHO conduct a second pre-hearing conference?
- 7. What deadline should the hearing officer set for submission of closing briefs?
- 8. Are there any other issues that any of the parties want to address during this prehearing conference?

The parties do not need to file pre-hearing conference statements but may if they want to. Any party that wants to file a pre-hearing conference statement shall file it by e-mail to the AHO at adminhrgoffice@waterboards.ca.gov, and shall include all the e-mail addresses in the service list for this proceeding in the e-mail's cc line.

The AHO will not order a court reporter for this pre-hearing conference. Any party may order a court reporter at that party's own expense.
