Footnotes

1: Waste Discharge Requirement (WDR) - California Water Code Section 13374 outlines that Waste Discharge Requirements (permits) may be issued by Regional Water Boards to regulate point discharges of fluids, including oil field produced water ponds. All facilities covered by a WDR must meet water quality objectives set by the Regional Water Board and are inspected regularly.

2: WDR permits are pending for active unpermitted ponds. The Central Coast Regional Water Board is permitting unpermitted ponds, when appropriate, on a case-by-case basis. At this time all ponds the the Central Coast Region have an active WDR. The Central Valley Regional Water Board is in the process permitting unpermitted ponds, when appropriate, under general orders. Ponds that are not permitted under the pending Central Valley Regional Water Board general orders were originally scheduled to be closed by December 31, 2016. This deadline has been postponed until after the April 2017 Central Valley Regional Board meeting to allow for the general orders under consideration in the Central Valley Region to be adopted and obtained by operators.

3: Cleanup and Abatement Order (CAO) - California Water Code section 13304 allows Regional Water Boards to issue an order to a discharger to clean up and abate the effects of a discharge of contaminant(s) or threatened pollution or nuisance.

4: Information Order (13267 letter) - California Water Code Section 13267 allows Regional Water Boards to require dischargers to furnish technical or monitoring reports as necessary. The technical reports are used to evaluate the nature, extent, circumstances, and impacts of discharges to waters of the state. 5: Notice of Violation (NOV) - These letter notices are issued by Regional Water Boards to operators who have not responded to 13267 orders within the required time, have responded late, or have provided incomplete responses.

6. Pond Status Definitions:

Active - Facility has a pond(s) that is currently receiveing produced water.

Inactive - Facility has a pond(s) with a physical connection to a produced water source, but not currently receiving produced water.

Historical - Facility with no physical connection to a produced water source and that appears to have been out of service for an extended period of time.

Current - Ponds that are "Active" or "Inactive".
