JUDGMENT and
DECREE

1 The above entitled cause having been referred to the Division of Water
2 Resources of the Department of Public Works, State of California, as referee,
3 by an order of the above entitled Court, dated June 18, 1936, and made under
4 authority of law as conferred by Section 24 of the Water Commission Act of
5 the State of California, Statutes of 1913, Chapter 586, as amended (now
6 Sections 2000 to 2050, inclusive, of the Water Code); said order of reference
7 directing said referee to investigate the physical facts involved, hold
8 hearings, take testimony, determine any and all issues involved, make its
9 findings of fact and conclusions of law, and file its report as such referee;
10 notice of lis pendens having been recorded in Modoc County, July 7, 1936
11 at 10:35 A.M. in Liber 23 of Official Records at page 334 and in Lassen
12 County, July 9, 1936 at 9:40 A.M. in Book 13 of Official Records at page
13 402; said referee having made its investigation and thereafter the party
14 plaintiff and all of the parties defendant, except John T. Bath, Alice B.
15 Walker, Carrie F. Stone, Wm. H. Bean, A. L. Cannon, W. E. Clark, Donnie
16 Clark, Peter Gerig, Leona P. Gerig, W. H. Gerig, R. L. Holmes, May L. Holmes,
17 Wm. Kramer, Rachel R. Kramer, E. J. Schmidt, Emma B. Schmidt, Alta J. Wallace,
18 Daisy H. Smith, J. A. Clark, Antone Avilla, Winifred Avilla, Alice Gray,
19 E. A. Armstrong, Lovertie Armstrong, Floyd E. Walker, J. E. Albaugh, Carrie O.
20 Albaugh, Frank Studley, Hattie Studley, Kasper Weigand and Itta Weigand,
21 having entered into a written stipulation for judgment; said stipulation for
22 judgment providing for settlement and determination of all issues involved
23 in said cause among, and by and between, said signatory parties having been
24 filed in said cause; said referee having announced its report in the form
25 of a draft; notice of said draft and a copy thereof having been mailed by
26 said referee to the parties or their attorneys; defendant C. W. Clarke Co.,
27 a corporation, R. L. Holmes and May L. Holmes, W. E. Clark and Donnie Clark
28 and John B. Conlan having filed objections to said draft of report and the
29 time for filing objections thereto having thereafter expired; said ob-
30 jections having been heard before said Division of Water Resources,
31 evidence both oral and documentary having been introduced at said hearing,

1 the evidence having been closed and the objections of C. W. Clarke Co., and
2 R. L. Holmes and May L. Holmes having been submitted on briefs filed by
3 Messrs. Carr and Kennedy and Hardin Barry; due consideration having been given
4 by said referee to said objections so filed; said referee having filed its
5 report herein including three hydrographic reports and map sheets showing soil
6 types, diversion systems, irrigated lands and the Ash Creek stream system; said
7 referee having given notice by mail to the parties or their attorneys of the
8 filing of its report; exceptions to said report of referee having been filed
9 by defendants R. L. Holmes and May L. Holmes and the time for filing exceptions
10 thereto having thereafter expired; said cause came on regularly for hearing and
11 trial before this Court sitting without a jury, on the 5th day of April, 1943,
12 and was duly and regularly continued to May 27, 1943 for further hearing and
13 trial; Carr and Kennedy appearing as counsel for exceptors, R. L. Holmes and
14 May L. Holmes; Hardin Barry appearing as counsel for defendants C. W. Clarke
15 Co., A. L. Cannon, J. C. Lane, Frank Studley and Hattie Studley, Floyd E.
16 Walker, J. E. Albaugh and Carrie O. Albaugh, Kasper Weigand and Etta Weigand,
17 M. D. Wayman and Alice M. Wayman, T. A. Barrows and Lulu M. Barrows, John T.
18 Bath, Alice B. Walker, Carrie F. Stone, Ora Lee Fleming and Estate of J. J.
19 Fleming, deceased, G. H. Perkins and Eltha A. Perkins, Herbert S. Bath and
20 Anne Bath, John Vogt and Louise Vogt, J. E. Yowell and Alice Gray; Spencer
21 Burroughs and Henry Holsinger appearing as counsel for referee; evidence both
22 oral and documentary having been submitted by exceptors R. L. Holmes and May L.
23 Holmes, by defendants opposed to said exceptions and by referee; the Court
24 having instructed referee to report upon changes in parties and ownership in-
25 volved and corrections which should be carried into the judgment; briefs hav-
26 ing been submitted by Carr and Kennedy, attorneys for exceptors and by Hardin
27 Barry, attorney for defendants opposed to said exceptions; referee having sub-
28 mitted written information and recommendations re parties and ownerships; the
29 Court having issued an order to show cause, if any, why findings and judgment
30 should not follow pursuant to said information and recommendations of referee,
31 which document was annexed to and made a part of said order to show cause;

1 referee having served, upon all parties and persons affected, a notice of said
2 order to show cause with a copy thereof annexed to and made a part of said
3 notice; a hearing on said order having been held before the court on the 11th
4 day of April, 1944; evidence having been submitted at said hearing and the
5 Court having found that Rhoda McGarva and Robert McGarva are successors in
6 interest of defendant T. J. Rice, sued herein as J. T. Rice, as to the lands
7 and water rights pertaining to the property known as Upper Place, and located
8 on Johnson Creek in Sections 11 and 14, T. 40 N., R. 9 E., M.D.B. &M.; a
9 stipulation having been filed on April 10, 1944 for the substitution of W. H.
10 Hunt Estate Company, a corporation, for and in lieu of defendant C. W. Clarke
11 Col, a corporation, and the court having ordered said substitution at said
12 hearing; said information and recommendations submitted by referee having been
13 approved and adopted by the court as supplemented by the foregoing finding
14 as to ownership and said order of substitution; the court having ordered sub-
15 stitutions of parties as follows:

3 name served as John Doe and also as J. T. Bath;
4 (19) Defendant Carrie F. Stone is sued herein as Mrs. Stone fictitious
5 name served under Alice Roe and also as Mrs. Stone;
6 (20) Defendants James A. Hollenbeck and Lela Hollenbeck, his wife,

12 and the cause having been submitted and the Court having made and filed herein
13 its findings of fact and conclusions of law, now therefore in accordance with
14 said findings of fact and conclusions of law,
15 IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:
16 1. Said report of referee, with subsequent substitutions or other
17 changes of parties and as heretofore corrected as shown by the record here-
18 in, is affirmed and adopted as the basis for the decree of this Court
19 determining and establishing the respective rights of each and every party
20 as against each and every other party in and to the use of the waters of
21 Ash Creek and its tributaries involved in said cause; and said report of
22 referee constitutes prima facie and expert evidence upon each and all
23 issues presented by the pleadings or proof presented herein.
24 2. All of the rights hereinafter set forth are subject to all
25 definitions, limitations and provisions hereinafter set forth under the
26 heading "GENERAL DEFINITIONS, LIMITATIONS AND PROVISIONS".
27 3. W. H. Hunt Estate Company is a corporation organized and existing
28 under and by virtue of the laws of the State of California, having its
29 office and place of business in Redding, California, and is hereinafter
30 referred to as W. H. Hunt Estate Company.

GENERAL STATEMENT OF CASE

1 4. There is in the counties of Modoc and Lassen, State of California,
2 a natural stream of water known as and called "Ash Creek", which said stream
3 originates at an elevation of approximately 6,000 feet on the west slope
4 of the range of mountains lying between the town of Bieber and the city of
5 Alturas, which range extends in a northerly direction from the northern
6 extremity of Modoc Plains in north central Lassen County to Pit River
7 Canyon, near Stone Coal Valley, in Modoc County. Said Ash Creek flows in
8 a northwesterly course from its source to the town of Adin and thence
9 westerly to its confluence with Pit River about three miles north of the
10 town of Bieber, and said stream has three important tributaries, namely,
11 Rush Creek, Butte Creek, and Willow Creek; said stream and tributaries
12 so flow between well defined banks in well defined channels to, upon and
13 across all of the lands embraced in the legal subdivisions hereinafter
14 set forth in Schedule 1, except the acreages described under the names of
15 Ardella Babcock and Estate of Andrew Babcock, deceased, Arad Babcock,
16 Lester A. Babcock and Frances B. Babcock, Oral Lester Babcock, the Holmes
17 Pond land described under the names of R. L. Holmes and May L. Holmes,
18 and the Headquarters Ranch and Pit River Place described under the name
19 of W. H. Hunt Estate Company. All of the water users in the entire water-
20 shed of said Ash Creek are involved in the above entitled action.

21 5. The rights involved in said action fall into four groups,

22 designated as follows:

23 (a) Rush Creek Group, which embraces all the rights on
24 Rush Creek and its tributaries;

25 (b) Butte Creek Group, which embraces all the rights on
26 Butte Creek and its tributaries;

27 (c) Willow Creek Group, which embraces all the rights
28 on Willow Creek and its tributaries; and

29 (d) Ash Creek Group, which embraces all other rights in
30 the stream system not included in the three above named
31 groups.

30 6. Parties to said action are entitled to "interrelated" and

31 "special class" water rights. All allocations of said "interrelated" water

1 rights in each of said groups in said stream system, to wit, Rush Creek,
2 Butte Creek, Willow Creek and Ash Creek groups, occur in various priority
3 classes and are as hereinafter respectively set forth in Schedules 3, 4
4 and 5, and in paragraphs 18, 19, 20 and 21 and Schedule 6; and each of
5 said Rush Creek, Willow Creek and Ash Creek groups, contains rights in
6 "special class" in addition to said allocations of "interrelated" water
7 rights. Said rights in "special class" are independent of each other,
8 are superior to said "interrelated rights" and are hereinafter set forth
9 in Schedule 7. All rights set forth in each of said Schedules 3, 4 and 5
10 are independent of all rights in the remaining two of said schedules, but
11 are all interrelated with the rights set forth in paragraphs 18, 19, 20 and
12 21 and Schedule 6.

GENERAL DEFINITIONS, LIMITATIONS AND PROVISIONS

15 7. The points of measurement of all allotments of water herein set
16 forth shall be at or near the respective points of diversion from Ash Creek
17 and its tributaries, except as hereinafter otherwise provided in paragraphs 18,
18 19 and 21.

19 8. Although all quantities of water herein allotted to the several
20 parties for direct application to beneficial use are severally expressed in
21 terms of continuous flow, nevertheless, nothing herein contained shall be
22 construed as limiting or restricting the rights of any such parties to rotate
23 in the use of water, or the right of any party hereto to divert for limited
24 periods of time convenient "irrigation heads" and thus apply water to his
25 lands at a greater rate than indicated by the continuous flow so allotted;
26 provided, that such practice of rotation or use of "irrigation heads" shall
27 not result in the use by any such party of a total quantity of water during
28 any thirty-day period in excess of the equivalent of such party's continuous
29 flow allowance for thirty days; except water may be diverted under each right
30 herein set forth in "fourth priority class" in Schedule 5 and in "fourth
31 priority class" and "fifth priority class" in Schedule 6 at a rate greater

1 than the continuous flow allotment hereinafter set forth therefor, provided
2 that such diversion does not result in the use under any of said rights of
3 a total quantity of water during any ninety-day period in excess of the
4 equivalent of said continuous flow allowance for the respective right for
5 ninety days; and provided further, that such practice of rotation or such
6 use of "irrigation heads" shall not impair or infringe the right of any
7 other such party.

8 9. Nothing herein contained shall, or shall be construed to, pre-
9 vent any of the parties hereto, who jointly use a ditch, where there is
10 a continuous flow allotment to said ditch, from employing by agreement of
11 such joint users of said ditch a system of rotation in use as among them-
12 selves; or prevent any party hereto who has allotments to two or more
13 ditches, from using all or any portion of the summation of such allotments
14 through each or any of said ditches on all or any portion of his lands,
15 provided the total quantity of water diverted by said party at any time
16 shall not exceed said summation of such allotments; and provided further,
17 that such practice of "pooling allotments" shall not impair or infringe
18 the rights of any other such party.

19 10. The "Division of Water Resources Map", herein referred to, is the
20 map prepared by the Division of Water Resources of the Department of Public
21 Works of the State of California, from its surveys made pursuant to its
22 functions as referee in said cause, which map comprises three sheets, is
23 entitled "Ash Creek Stream System Showing Diversions and Irrigated Lands,
24 Modoc-Lassen Counties, California", is dated 1937, and has been filed in
25 said cause.

DEFINITION OF WATER RIGHTS

27 11. The various parties to the above entitled action are entitled to
28 use of the waters of the Ash Creek stream system upon, and are the owners
29 and in possession of the irrigated lands hereinafter described under their
30 respective names in Schedule 1; and all allotments of water hereinafter set
31 forth shall be diverted from said Ash Creek stream system at the present

1 points of diversion of the respective ditches as hereinafter named, numbered
2 and described in Schedule 2.

3 12. The parties hereinafter enumerated in Schedule 7 are entitled to
4 divert, during the seasons hereinafter stated in paragraph 13, the allot-
5 ments of water specified from the sources and through the diversions set
6 forth after their respective names in said Schedule 7 under rights in
7 "special class" and apply said allotments of water to beneficial use
8 for domestic, stock-watering and irrigation purposes upon their re-
9 spective lands as shown on said Division of Water Resources Map and as
10 described under their respective names in Schedule 1 hereof; and said
11 rights in "special class" set forth in said Schedule 7 are independent
12 of each other but are superior in priority and in right to all other
13 rights on Ash Creek and its tributaries. All rights in the Ash Creek
14 stream system, other than said rights in "special class", are inter-
15 related and occur in four groups as hereinbefore designated in Paragraph
16 5, and as hereinafter respectively set forth in Schedules 3, 4 and 5,
17 and in paragraphs 18, 19, 20 and 21 and Schedule 6. All rights set forth
18 in each of Schedules 3, 4, and 5 are independent of all rights in the
19 remaining two of said schedules but are superior in priority and in
20 right to all rights set forth in said paragraphs 18, 19, 20 and 21 and
21 Schedule 6.

22 13. All allotments set forth in Schedules 3 and 4 hereof, all
23 allotments of second priority class, third priority class, and fourth
24 priority class in Schedule 5 hereof, all allotments of "first priority
25 class" set forth in Schedule 6 hereof for John T. Bath, Alice B. Walker
26 and Carrie F. Stone; Robert Fleming and Ora Lee Fleming; John T. Bath,
27 Alice B. Walker, Carrie F. Stone, Robert Fleming, Mary Fleming, and Ora
28 Lee Fleming; G. H. Perkins and Eltha A. Perkins; T. A. Barrows and Lulu
29 Barrows; and John A. Kresge and May E. Kresge; and all allotments herein-
30 after provided in Schedule 7 for Diversions 56, 57, 58, 59, 60, 1, 2, 3, 8,
31 4, 5, 6, 107, 106, 98, 99, 100, 103, 105 and 109 shall be for continuous

1 usage during the season from April 1 to October 15, both dates inclusive,
2 of each and every year; and the parties, who are herein allocated the above
3 stated allotments for said season from April 1 to October 15, both dates
4 inclusive, are entitled to divert from the natural flow of Ash Creek and its
5 tributaries through their respective diversion systems, such amounts of water
6 as may be required for domestic and stock-watering purposes on their lands,
7 hereinafter described under their respective names in Schedule 1, during the
8 period from October 15 of each year to March 31 of the succeeding year, both
9 dates inclusive. All allotments of "first priority class" set forth in
10 said Schedule 6 for W. E. Clark and Donnie Clark, J. E. Yowell, Addie
11 Yowell, F. E. Yowell and Dorothy Yowell, Louise Vogt and John Vogt, and
12 W. H. Hunt Estate Company, all allotments of "third priority class", "fourth
13 priority class" and "fifth priority class" set forth in said Schedule 6,
14 the allotments hereinafter provided in Schedule 7 for Alta J. Wallace and
15 Daisy H. Smith, and W. H. Hunt Estate Company shall be for continuous usage
16 during the season from March 1 to October 15, both dates inclusive, of each
17 and every year; and the parties, who are herein allocated the above stated
18 allotments for said season from March 1 to October 15, both dates inclusive,
19 are entitled to divert from the natural flow of Ash Creek and its tributaries
20 through their respective diversion systems, such amounts of water as may be
21 required for domestic and stock-watering purposes on their lands, hereinafter
22 described under their respective names in Schedule 1, during the period from
23 October 15 of each year to the last day of February of the succeeding year,
24 both dates inclusive. The allotments of "second priority class" set forth
25 in said Schedule 6 for A. L. Cannon and W. H. Hunt Estate Company and the
26 allotments hereinafter provided in said Schedule 7 for Diversions 96, 90, 108,
27 101, 102 and 104 shall be for continuous usage without regard to season. The
28 right hereinafter provided in the Holmes Pond for R. L. Holmes and May L.
29 Holmes in said Schedule 7 for the storage of the waters tributary to said
30 Holmes Pond shall be for diversion to storage at any season of the year
31 whenever there is water available from said source and the rights hereinafter

1 provided in paragraphs 18, 19, 20 and 21 shall be for the periods set forth
2 in said paragraphs 18, 19, 20 and 21.

3 14. Subject to such of the "special class" rights herein defined
4 in paragraph 12 and Schedule 7 as are in said Rush Creek Group, the
5 various parties enumerated in Schedule 3 hereof are entitled to rights
6 in and to the use of the natural flow of Rush Creek and its tributaries
7 during the seasons hereinbefore stated in paragraph 13, for domestic,
8 stock-watering and irrigation purposes upon their respective lands as
9 shown on said Division of Water Resources Map and as described under
10 their respective names in Schedule 1 hereof, in accordance with the
11 acreages to be supplied and quantities of water allotted, at the points
12 of diversion as numbered and through the diversion systems as named after
13 their respective names in said Schedule 3. All of said rights in said
14 Schedule 3 are equal in priority and correlative in right, and at all
15 times when the available water supply of Rush Creek and its tributaries
16 is inadequate to supply all of said rights set forth in Schedule 3, then
17 during the continuance of such shortage, the owners of such rights shall
18 prorate the available water supply, if any, in excess of the quantity re-
19 quired to supply said prior rights, in accordance with their respective
20 allotments as set forth in said Schedule 3.

21 15. The various parties enumerated in said Schedule 4 hereof are
22 entitled to rights in and to the use of the natural flow of Butte Creek
23 and its tributaries during the seasons hereinbefore stated in paragraph 13,
24 for domestic, stock-watering and irrigation purposes upon their respective
25 lands as shown on said Division of Water Resources Map and as described
26 under their respective names in Schedule 1 hereof, in accordance with the
27 acreages to be supplied, priorities and quantities of water allotted, and
28 at the points of diversion as numbered and through the diversion systems
29 as named after their respective names in said Schedule 4. Said rights in
30 "first priority class" are equal in priority and correlative in right,
31 are superior in priority and in right to all other rights in said Schedule

1 4, and at all times when the available water supply of Butte Creek and
2 its tributaries is inadequate to supply all of said rights in "first prior-
3 ity class", then during the continuance of such shortage, the owners of
4 such rights shall prorate the available water supply in accordance with
5 their respective allotments in said "first priority class" as set forth
6 in said Schedule 4. Said right in "second priority class" is inferior
7 and subject to all other rights set forth in said Schedule 4.

8 16. Subject to such of the "special class" rights hereinbefore de-
9 fined in Paragraph 12 and Schedule 7 as are in the Willow Creek Group,
10 the various parties enumerated in said Schedule 5 hereof, are entitled to
11 rights in and to the use of the natural flow of Willow Creek and its trib-
12 utaries during the seasons hereinbefore stated in Paragraph 13, for do-
13 mestic, stock-watering and irrigation purposes upon their respective lands
14 as shown on said Division of Water Resources Map and as described under
15 their respective names in Schedule 1 hereof, in accordance with the acreages
16 to be supplied, priorities and quantities of water allotted, at the points
17 of diversion as numbered and through the diversion systems as named in said
18 Schedule 5. Said rights in "first priority class" are equal in priority
19 and correlative in right, but are superior in priority and in right to all
20 other rights in said Schedule 5, and at all times when the available water
21 supply of Willow Creek and its tributaries is inadequate to supply all of
22 said rights in "first priority class", then during the continuance of such
23 shortage, the owners of such rights shall prorate the available water supply,
24 if any, in excess of the quantity necessary to supply said prior rights,
25 in accordance with their respective allotments in said "first priority
26 class" as set forth in said Schedule 5, with the exception of the allotment
27 of 0.10 cubic foot per second in said "first priority class" to Kasper
28 Weigand and Etta Weigand, which may be diverted and applied to beneficial
29 use by Frank Studley and Hattie Studley, provided however, that said Frank
30 Studley and Hattie Studley shall at all times permit 0.10 cubic foot per
31 second to flow onto the lands of said Kasper Weigand and Etta Weigand here-
32 inafter described under their names in Schedule 1 either down the natural

1 channel of said Willow Creek or in the form of drainage from the Studley
2 Ranch, except during the months of July and August said Frank Studley and
3 Hattie Studley may elect to deliver said 0.10 cubic foot per second to
4 said Weigand lands through the Studley-Johnson Ditch by means of the
5 Weigand stock-watering tap therefrom. Said rights in "second priority
6 class" are equal in priority and correlative in right, are subject and
7 inferior to said rights in "first priority class", but are superior in
8 priority and in right to all other rights in said Schedule 5, and at all
9 times when the available water supply of Willow Creek and its tributaries
10 is inadequate to supply all of said rights in "second priority class",
11 then during the continuance of such shortage, the owners of such rights
12 shall prorate the available supply, if any, in excess of the quantity
13 required to supply said prior rights, in accordance with their respective
14 allotments in said "second priority class" as set forth in said Schedule
15 5. Said right in "third priority class" is inferior and subject to said
16 rights in "first priority class" and "second priority class" but is super-
17 ior in priority and in right to all other rights in said Schedule 5. All
18 of said parties who have allotments in either "first priority class",
19 "second priority class" or "third priority class", as set forth in said
20 Schedule 5, are entitled to spread and apply to beneficial use upon their
21 lands hereinafter described under their respective names in Schedule 1,
22 any drainage rising on or return flow flowing onto their respective lands
23 as a result of water applied to beneficial use for irrigation purposes on
24 adjoining upstream lands, provided however, that nothing herein contained
25 shall, or shall be construed to permit any party hereto to divert a quantity
26 of water in excess of the quantity reasonably necessary for his require-
27 ments for beneficial use. Said rights in "fourth priority class" are equal
28 in priority and correlative in right, are inferior and subject to all other
29 rights in said Schedule 5, and at all times when the available water supply
30 of Willow Creek and its tributaries is inadequate to supply all of said
31 rights in "fourth priority class", then during the continuance of such

1 shortage, the owners of such rights shall prorate the available water supply,
2 if any, in excess of the quantity required to supply said prior rights,
3 in accordance with their respective allotments in said "fourth priority
4 class" as set forth in said Schedule 5. Whenever the available water supply
5 of Willow Creek and its tributaries is in excess of 12.60 cubic feet
6 per second (the aggregate of allotments in said Schedule 5), water
7 may be diverted from such excess under all rights in said "fourth prior-
8 ity class" at greater rates of diversion than respectively set forth
9 therefor in said Schedule 5, subject to the provisions hereinbefore set
10 forth in Paragraph 8.

11 17. Subject to all rights hereinbefore defined, the various claim-
12 ants enumerated in Schedule 6 hereof, are entitled to rights in "first
13 priority class", "second priority class", "third priority class", "fourth
14 priority class" and "fifth priority class", in and to the use of the
15 natural flow of Ash Creek and its tributaries, during the seasons herein-
16 before stated in Paragraph 13, for domestic, stockwatering and irrigation
17 purposes upon their respective lands as shown on said Division of Water
18 Resources Map and as described in Schedule 1 hereof, in accordance with
19 the acreages to be supplied, priorities and quantities of water allotted,
20 at the points of diversion as numbered and through the diversion systems
21 as named in said Schedule 6. Said rights in "first priority class" are
22 equal in priority and correlative in right, but are superior in priority
23 and in right to all other rights in said Schedule 6, and at all times when
24 the available water supply of Ash Creek and its tributaries is inadequate
25 to supply all of said rights in "first priority class", then during the
26 continuance of such shortage, the owners of such rights shall prorate the
27 available water supply, if any, in excess of the quantity required to supply
28 said prior rights, in accordance with their respective allotments in said
29 "first priority class" as set forth in said Schedule 6; and the use of
30 the Vogt Ditch by J. E. Yowell, Addie Yowell, F. E. Yowell and Dorothy
31 Yowell to convey 0.35 cubic foot per second, as set forth in said Schedule

1 6, is permissive and said ditch is subject to the exclusive control of
2 Louise Vogt and John Vogt. Said rights in "second priority class", are
3 equal in priority and correlative in right, are subject and inferior to
4 said rights in "first priority class", but are superior in priority
5 and in right to all other rights in said Schedule 6, and at all times
6 when the available water supply of Ash Creek and its tributaries is in-
7 adequate to supply all of said rights in "second priority class" and
8 the rights hereinafter defined in Paragraph 19, then during the continu-
9 ance of such shortage, the owners of such rights shall prorate said avail-
10 able water supply, if any, in excess of the quantity required to supply
11 all prior rights, in accordance with their respective allotments in said
12 "second priority class" as set forth in Schedule 6 and Paragraph 19.
13 Said rights in "third priority class", are equal in priority and cor-
14 relative in right, are inferior and subject to said rights in "first
15 priority class", and "second priority class" but are superior in priority
16 and in right to all other rights in said Schedule 6, and at all times when
17 the available water supply of Ash Creek and its tributaries is inadequate
18 to supply all of said rights in "third priority class" and the rights
19 hereinafter defined in Paragraph 20, then during the continuance of such
20 shortage, the owners of such rights shall prorate the available water
21 supply, if any, in excess of the quantity required to supply all prior
22 rights, in accordance with their respective allotments in said "third
23 priority class" as set forth in said Schedule 6 and Paragraph 20. Said
24 rights in "fourth priority class" are equal in priority and correlative
25 in right, are inferior and subject to said rights in "first priority class",
26 "second priority class", and "third priority class", but are superior in
27 priority and in right to all other rights in said Schedule 6, and at all
28 times when the available water supply of Ash Creek and its tributaries is
29 inadequate to supply all of said rights in "fourth priority class", then
30 during the continuance of such shortage, the owners of such rights shall
31 prorate the available water supply, if any, in excess of the quantity required

1 to supply all prior rights, in accordance with their respective allot-
2 ments in said "fourth priority class" as set forth in said Schedule 6.
3 Said rights in "fifth priority class", are equal in priority and
4 correlative in right, are inferior and subject to all other rights in
5 said Schedule 6, and at all times when the available water supply of Ash
6 Creek and its tributaries is inadequate to supply all of said rights in
7 "fifth priority class", then during the continuance of such shortage, the
8 owners of such rights shall prorate the available water supply, if any,
9 in excess of the quantity required to supply all prior rights, in accord-
10 ance with their respective allotments in said "fifth priority class" as
11 set forth in said Schedule 6. Whenever the total flow available for
12 diversion from said Ash Creek is in excess of the aggregate of allotments
13 under the rights set forth in said Schedule 6 and paragraphs 19 and 20,
14 water may be diverted from such excess under all rights in said "fourth
15 priority class" and "fifth priority class" at greater rates of diversion
16 than respectively set forth therefor in Schedule 6, subject to the pro-
17 visions hereinbefore set forth in Paragraph 8. All allocations set forth
18 in said Schedule 6 to W. H. Hunt Estate Company, a corporation, are
19 subject to the provisions hereinafter set forth in Paragraph 18.

20 18. W. H. Hunt Estate Company, a corporation, from the waters herein
21 allocated to said corporation from Ash Creek, is entitled to and shall
22 deliver 5.30 cubic feet per second for irrigation, domestic and stock-
23 watering purposes by means of the Big Valley Drainage Canal, which diverts
24 at a point designated on said Division of Water Resources Map as
25 Diversion 26, as hereinafter described in Schedule 2, during three periods
26 of fifteen days in each period between June 20 and the close of the irri-
27 gation season, or instead of and in lieu of said amount of water for said
28 periods, said W. H. Hunt Estate Company is entitled and empowered to deliver
29 7.95 cubic feet per second from waters herein allocated to said corporation
30 from said creek through said canal during two periods of fifteen days in
31 each period, all in accordance with the decree of the Superior Court of the
32 State of California, in and for the County of Modoc in Case No. 2789, en-
33 titled, "A. Babcock, et al. vs. C. W. Clarke Co., et al.", subject to the

1 regulations of the Public Utilities Commission of the State of California;
2 and at such times said deliveries of water, which involve changes in point
3 of diversion and place of use of a portion of the waters herein allocated
4 to said W. H. Hunt Estate Company, may be made by said corporation free of
5 obligation to return to the Ash Creek stream system any portion of the
6 drainage therefrom and said corporation at such time shall not be obligated
7 to bear any portion of the transportation losses occasioned through the
8 exercise of rights set forth in Schedule 6 hereof for diversion through
9 Diversions 25 to 45, inclusive, and 52 to 54, inclusive.

10 19. Plaintiff Charles A. Gerig and defendants R. L. Holmes and May L.
11 Holmes, W. H. Hunt Estate Company, C. M. Leonard and Cynthia Leonard,
12 J. P. Miller and Clara Miller, Kasper Weigand and Etta Weigand, A. H.
13 Brunselmeir and Bertie Brunselmeir, and M. D. Wayman and Alice M. Wayman,
14 are at all times entitled to divert such quantities of water from the
15 natural flow of Ash Creek as will result in deliveries through the Big
16 Valley Drainage Canal, described in Schedule 2 hereof, from the taps and
17 in the amounts set forth after their respective names as follows:

16 Ash Creek diversions, hereinafter respectively described in Schedule 2
17 under Diversions 52 and 53, such quantities of water as are necessary to
18 supply the deficiency, if any, in the natural flow of Pit River available
19 to meet their respective water requirements set forth after their respective
20 names as follows:

Peter Gerig and Leona P. Gerig - 5.51 cubic feet per second
W. H. Gerig - 3.67 cubic feet per second

to be used as a supplemental supply for irrigation purposes upon their lands described under their respective names in Schedule 1 hereof; and said rights of said Peter Gerig and Leona P. Gerig, and W. H. Gerig are inferior and subject to all rights set forth in Schedules 3, 4, 5 and 7 hereof and from said Ash Creek in "first priority class" and "second priority class" set forth in Schedule 6 hereof, and are equal in priority and correlative in right with all rights in "third priority class" set forth in said Schedule 6, but are superior in priority and in right to all rights in "fourth priority class" and "fifth priority class" set forth in said Schedule 6.

1 21. Subject to all rights hereinbefore set forth, defendants R. L.
2 Holmes and May L. Holmes are entitled to take, during the period from June 20
3 to October 15 of each year, 1.70 cubic feet per second from waters flowing
4 in the Big Valley Drainage Canal through the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 9, T. 38 N.,
5 R. 8 E., M.D.B. & M., by means of the Steiger Taps, subject to the prior
6 rights hereinbefore set forth in Paragraphs 17, 18, and 19, for the irriga-
7 tion of 136.6 acres of their Holmes Pond lands, lying north of the Bieber-
8 Adin State Highway, hereinafter described under their names in Schedule 1;
9 provided however, said defendants have no right to cause or require that
10 water be diverted from Ash Creek into the Big Valley Drainage Canal for said
