ORDER GRANTING EXTENSION OF TIME AND REINSTATING
CANCELLED APPLICATIONS 25144, 25843, 25844, AND 25845

BY THE BOARD:

North Canyon Lake Association having filed Application 25144;
Richard E. Winkelman and Juanita M. Ward having filed Application 25843;
Gary W. and Jeannie M. Jackson having filed Application 25844 (now in the
name of Karl E. and Quella A. Hart); Owen J. and Pamela R. Masters having
filed Application 25845; protests having been received; a public hearing
having been commenced on August 24, 1978 and continued to August 9, 1979;
Decision 1578 having been adopted by the Board on September 17, 1981; said
Decision having deferred action on the applications and having provided that
the applicants were allowed one year in which to reach an agreement regarding
right of access to Larsen Dam and the reservoir site or to file a lawsuit
to resolve access issues; the applicants having failed to act within the
year specified in Decision 1578; the applications having been cancelled
by orders dated October 7, 1982: the attorney for the parties applicants under
Applications 25843, 25844 and 25845 having requested reconsideration of the
order cancelling the applications and having requested an extension of time
allowed for initiation of legal proceedings; said attorney having filed a

lawsuit to resolve the access issue on November 8, 1982; the North Canyon Lake Association having advised the Board by letter dated November 6, 1982, that it opposes reinstatement of the applications and any extension of time; Decision 1578 having authorized extensions of time for good cause shown; the Board, having considered all the evidence relevant to this matter, finds as follows:

1. As explained in Decision 1578, the issue of access to Larsen Reservoir and Dam site must be resolved before any of the applications will be approved.

2. A lawsuit seeking to resolve conflicting claims of rights of access to Larsen Reservoir and Dam site was filed on November 8, 1982.

3. A negotiated settlement of the access issue remains possible and is the solution preferred by the Board, provided it is entered into within the time limit provided in Order paragraph (b) of Decision 1578.

It is concluded that the request for reconsideration should be granted and that the Board should also grant an extension of time from the schedule specified in Decision 1578.

NOW, THEREFORE, IT IS ORDERED THAT:

1. The request for reconsideration of the cancellation of Applications 25144, 25843, 25844, and 25845 is granted.

2. The time for filing the lawsuit referred to in Decision 1578 is extended to November 8, 1982.

3. Applications 25144, 25843, 25844, and 25845 are reinstated.

4. Except as modified herein, the time schedule and all other provisions of Decision 1578 remain in effect.
