ORDER VALIDATING ISSUANCE OF TEMPORARY URGENCY CHANGE ORDER

BY THE BOARD:

The El Dorado Irrigation District (District) having filed a petition for a temporary urgency change in the points of diversion and storage, point of rediversion and distribution in storage pursuant to Chapter 6.6 (commencing with Section 1435, Part 2, Division 2 of the Water code; the Board having consulted with the Department of Fish and Game; Chairman W. Don Maughan concluded from available information that a temporary urgency change order should be issued and having issued said order; and the order being subject to review and validation by the Board as provided by Water Code Section 1435(d) the Board finds as follows:

Substance of the Proposed Change

 On September 13, 1988, the District obtained Temporary Permit 20264 to divert and store 5,000 acre-feet of water in Jenkinson Lake, behind Sly Park Dam. The water was conveyed to Jenkinson Lake by means of the existing Pacific Gas and Electric Company El Dorado Canal which diverts water from the South Fork American River near Kyburz and the recently completed Hazel Creek Tunnel which conveys El Dorado Canal water into Hazel Creek, which flows into Jenkinson Lake. The permit authorized the diversion of water from the South Fork American River and Alder Creek at the maximum rate of diversion to offstream storage of 50 cubic feet per second.

Temporary Permit 20264 expired on February 28, 1989.

- 2. On February 27, 1989, the District filed a petition for a temporary urgency change to add points of diversion and storage at Caples Lake and Silver Lake; a point of rediversion at the South Fork American River at Kyburz; and to redistribute 600 acre-feet of stored water from Jenkinson Lake to Caples Lake and/or Silver Lake.
- In accordance with Water Code Section 1435(d) and Resolution 84-2, Chairman Maughan approved the District's petition and issued a Conditional Temporary Urgency Change Order on February 28, 1989.
- 4. We concur in and incorporate herein by reference the findings set forth in the Order issued on February 28, 1989.

ORDER

IT IS HEREBY ORDERED THAT:

The February 28, 1989 order by Board Chairman Maughan allowing a Conditional Temporary Urgency Change in the distribution of storage and the addition of two

points of diversion and one point of rediversion is validated subject to the terms and conditions specified in the Order.
