Applications 13918, 24587, 26268 & 28891

First we request that the purpose of use for License 8261 be changed from Irrigation To irrigation, Frost Protection, Heat Control, Recreational & Fire Protection so that all licenses can show the same purpose of use.

We also request that the place of use for Licenses 8261, 12156 & 13088 be changed to show the same 100 acres as shown in License 11464 and that place of use under all of the licenses be amended to show the 28 acres approved by the Napa County Planning Commission in 1999 which is : 8 acres in the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 25 and 7 acres in NW $\frac{1}{4}$ of NW $\frac{1}{4}$, 12 acres in NW $\frac{1}{4}$ of SE $\frac{1}{4}$ and 1 acre in SW $\frac{1}{4}$ of SE $\frac{1}{4}$ all in Section 26, all in T8N, R4W, MDB&M and the 12 acres approved in 2001 as follows: 5 acres in SW $\frac{1}{4}$ of NE $\frac{1}{4}$ and 7 acres in SE $\frac{1}{4}$ of NW $\frac{1}{4}$, both in Section 26, T8N, R4W, MDB&M.

A copy of the Negative Declaration for the 12.1 acres approved in 2001 is included with this petition and the paper work for the 1999 approval of 28 acres will be forwarded as soon as obtained from the Napa County Planning Commission
