THE PERMITTED LOCATION OF THE P.O.D. HAS BEEN RELOCATED ±350' SOUTH BECAUSE OF CHANGES IN THE FLOW PATTERN OF RUSSIAN RIVER, AND EROSION. THIS PETITION SEEKS TO CREATE TWO MOVABLE P.O.D.'S ALONG THE STRETCH OF RUSSIAN RIVER THAT IS CONTIGUOUS TO THE VINEYARD BOUNDARY (± 1/2 MI). MOVING THE P.O.D. DOES NOT REQUIRE CHANGES TO ANY INFRASTRUCTURE, OR REMOVAL OF ANY VEGETATION. THIS PETITION ALSO SEEKS TO EXPAND THE PLACE OF USE TO COVER THE NORTHERN PORTION OF THE VINEYARD WHICH IS ALSO COVERED BY A 24617.



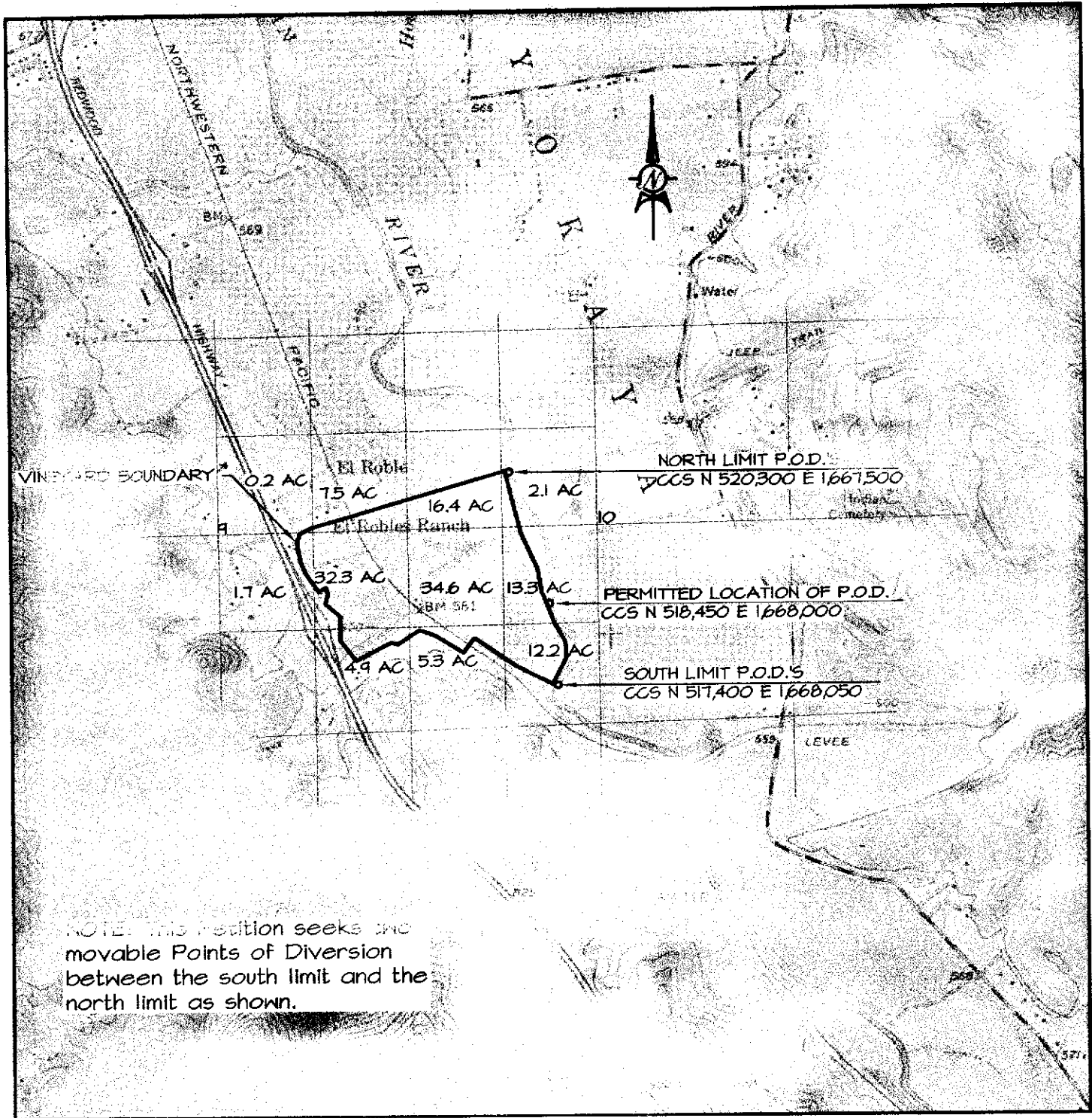
