The Petitioner proposes to increase the place of use from 27 acres to 53 acres as shown on the attached map and to add heat control and incidental fire protection as a purpose of use. The reservoir was built in 1984 and is used to serve the existing vineyard which was developed in 1984. All facilities are existing and the place of use is fully developed. No further construction or development will be required for changes requested in this petition.
