THIS PETITION SEEKS TO MAKE THE P.O.D UNDER LICENSE 878 MOVABLE ALONG THE STRETCH OF RUSSIAN RIVER THAT IS CONTIGUOUS TO THE VINEYARD BOUNDARY ($\pm 1/2$ MI.). THIS IS NECESSARY TO ACCOMODATE CHANGES IN FLOW PATTERNS OF THE RIVER, AND DOES NOT REQUIRE ANY CHANGES TO INFRASTRUCTURE OR REMOVAL OF ANY VEGETATION. THE PETITION ALSO SEEKS TO EXPAND THE PLACE OF USE TO INCLUDE THE NORTHERN PORTION OF THE VINEYARD WHICH IS ALSO COVERED BY LICENSE 8501 (A 16758).
