**NOTICE OF WASTEWATER CHANGE PETITION WW0070**

COUNTY: Napa

STREAM SYSTEM: Napa River

The City of Yountville has filed a wastewater change petition, seeking to change the place of use of treated wastewater to use up to 130 acre-feet per annum for irrigation purposes on vineyards in and around Yountville. Summary of Wastewater Discharge

Point of Discharge:	Present: Outfall at NAD 83, Zone 2, North 1,909,904 feet and East 6,463,496 being within NW ¼ of NE ¼ of projected Section 6, T6N, R4W, MDB&M  Proposed: No Change
Purpose of Use:	Present: Irrigation Proposed: No Change
Amount:	Present: The average discharge rate from 2004 to 2007 was 0.87 cubic feet per second, and the highest maximum daily rate during this period was 2.72 cubic feet per second. Due to the addition of new storage ponds in 2009, petitioner used 85% of its effluent for irrigation during the 2008/09 water year, discharging only 15% to the Napa River.  Proposed: Reduce to 0 cubic feet per second, except when inflows to treatment plant are greater than 0.78 cubic feet per second or project's storage ponds are full.
Place of Use:	Present: 809.8 acres within projected Sections 4, 5, 6, 7, 8, and 9, T6N, R4W; and projected Section 1, T6N, R5W.  Proposed: 1318.5 acres within projected Sections 4, 5, 6, 7, 8, and 9, T6N, R4W; projected Section 1, T6N, R5W; and projected Section 31, T7N, R4W.
Season:	October 1 through May 15 of the succeeding year
