NOTICE OF WASTEWATER CHANGE PETITION WW0092 OF SACRAMENTO REGIONAL COUNTY SANITATION DISTRICT

COUNTY: Sacramento

STREAM SYSTEM: Sacramento River

On August 3, 2016, Sacramento Regional County Sanitation District (Regional San) filed a wastewater change petition (WW0092) with the State Water Resources Control Board, Division of Water Rights pursuant to Water Code section 1211. With the petition, Regional San seeks authorization to reduce the discharge of treated wastewater from the Sacramento Regional Wastewater Treatment Plant into the Sacramento River by up to 50,000 acre-feet annually (afa) and direct that water to Regional San's proposed South Sacramento County Agriculture & Habitat Lands Recycled Water Program.
