Harvey S. Nyland and Gladys M Nyland 1999 Family Trust has filed a Petition for Change of License 6023 with the State Water Resources Control Board, Division of Water Rights seeking to split License 6023 into two rights since land covered by License 6023 has been divided between two separate owners. License 6023A will include five of the seven points of diversion with no expansion of place of use.
