NOTICE OF WASTEWATER CHANGE PETITION WW0107

COUNTY: Los Angeles

STREAM SYSTEM: San Jose Creek/San
Gabriel River

The Sanitation Districts of Los Angeles County (Petitioner) has filed a wastewater change petition with the State Water Resources Control Board, Division of Water Rights (Division) pursuant to Water Code section 1211. The Petitioner requests authorization to reduce the discharge of treated wastewater from the San Jose Creek Water Reclamation Plant to the San Gabriel River watershed as shown below during all months of the year based on recycled water demand. Summary of Wastewater Discharge and Proposed Change:

Source of Discharge:

San Jose Creek Water Reclamation Plant

Receiving Water:

San Jose Creek thence the San Gabriel River tributary to the Pacific Ocean

Points of Discharge:

Present: San Jose Creek Water Reclamation Plant discharge points at California Coordinate System, NAD 83, Zone 5: SJC001: North 1,797,145.62 feet and East 6,528,972.73 feet; SJC001A: North 1,820,267.50 feet and East 6,539,437.79; SJC001B: North 1,811,375.55 and East 6,534,798.54; SJC002: North 1,835,281.52 and East 6,555,279.46; and SJC003: North 1,835,511.82 and East 6,552,391.97.

Proposed: No Change

Rate of Discharge:

Present:

- 1) 5.4 million gallons per day (mgd) at SJC001 to the lined portion of the San Gabriel River;
- 2) 7.3 mgd at SJC001A to the unlined portion of the San Gabriel River;
- 3) 6.0 mgd at SJC001B to the unlined portion of the San Gabriel River;
- 4) 9.5 mgd at SJC002 to the unlined portion of San Jose Creek;
- 5) 0.0 mgd at SJC003 to the unlined portion of the San Gabriel River.

Proposed:

- 1) Zero discharge at SJC001 to the lined portion of the San Gabriel River with the possibility of some discharge in high rainfall years;
- 2) No change at SJC001A;
- 3) No change at SJC001B;
- 4) 5.0 mgd at SJC002 to the unlined portion of San Jose Creek with the possibility of some discharge in high rainfall years;
- 5) No change at SJC003, which is historically rarely used.

Note: All values are Water Years 2014-2018 annual averages
