This petition for a temporary urgency change seeks to reduce the minimum wastewater discharge into Deer Creek required by State Water Resources Control Board Order 95-9. That order requires the El Dorado Irrigation District ("District") to discharge a minimum of 0.5-1.0 mgd of treated wastewater into Deer Creek for the benefit of Deer Creek's riparian corridor. To meet this requirement, and the District's recycled water demand, the District must supplement its recycled water supply with potable water. Given the drought emergency, the District seeks this change.

Over the last thirty years the District's recycled water program has grown extensively. The District has one of the largest recycled water irrigation programs in the State, with over 4,000 metered connections. The majority of the services are for single-family homes which utilize recycled water for the irrigation of front and backyards of homes. In our service area, a typical home utilizes 60% of its total water demand for outside irrigation purposes. The District has two wastewater treatment plants that produce tertiary treated and disinfected recycled water for unrestricted reuse. The recycled water demand on our system is greater than our recycled water supply capabilities with the minimum discharge requirements of WRO 95-9. Consequently, the District supplements the recycled water system with potable water.

The District supplemented an average of 565 acre-feet of potable water into the recycled system in 2012 and 2013. In 2014, the District was able to reduce the potable water supplementation to 117 acre-feet, thereby saving nearly 450 acre-feet of potable water. The reduction in potable water supplementation was achieved through customer conservation on the recycled system and the implementation of the 2014 temporary urgency change petition that allowed a reduction in effluent discharge to Deer Creek and the use of additional recycled water for beneficial uses Water Rights Order WW0020 (WW0020). Per WW0020, the District was allowed an adaptive flow reduction approach, with the initial discharge reduction rate of 0.43 mgd. Qualified biologists conducted field a field analysis both pre and post discharge reduction and determined that the flow reduction had no adverse impact on the fish and wildlife in Deer Creek. As a result, the CDFW and the SWRCB allowed the District to reduce flows by 25% to 0.32 mgd. Again, biologists conducted a field analysis and determined that the 0.32 mgd discharge had no adverse impact on the fish and wildlife in Deer Creek. Deer Creek is an ephemeral stream that connects to the Cosumnes River in Sacramento County. During summer months, the stream goes dry a few miles below the District's point of discharge and connectivity to the Cosumnes River is cut off several miles upstream of the confluence. According to the SWRCB's Electronic Water Rights Information Management System, there are no appropriative water right holders on Deer Creek. Moreover, WRO 5-9 held that riparian right holders on Deer Creek have a right to the natural flow of Deer Creek, but not the effluent that is discharged into Deer Creek.

The District is requesting a temporary change order for the discharge to Deer Creek. The District is seeking a minimum discharge rate of 0.32 mgd from May 15, 2015 to December 15, 2015.
