## **Attachment 1 (Point of Diversion or Rediversion)**

### **Present:**

1. California Coordinate System of 1983, Zone 2, North 2,008,400 feet and East 6,667,100 feet, being within SE $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 27, T10N, R3E, MDB&M. (This is the location of the existing Reclamation District 2035 joint intake facility, which was used through 2015 for diversions under this license for irrigation purposes.)
2. California Coordinate System of 1983, Zone 2, North 2,008,200 feet and East 6,667,300 feet, being within NE $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 34, T10N, R3E, MDB&M. (This is the second authorized point of diversion in this license. It is the location of the new Woodland-Davis Clean Water Agency/Reclamation District 2035 joint intake facility. This facility is under construction but is not yet operational.)

Proposed: California Coordinate System of 1983, Zone 2, North 2,008,400 feet and East 6,667,100 feet, being within SE $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 27, T10N, R3E, MDB&M. (This is the location of the existing Reclamation District 2035 joint intake facility, which is proposed for use during the term of this temporary urgency change petition. This petition requests a temporary amendment of the fourth term on page 3 of this license, so that this point of diversion may be used during the term of the petition.)

## **Attachment 2 (Temporary Urgency)**

The Woodland-Davis Clean Water Agency (“WDCWA”), originally planned to complete the Davis-Woodland Water Supply Project (“DWWSP”) and to begin diverting water from the Sacramento River for this project after completion of the new joint intake facility that is being constructed by Reclamation District 2035 (“RD 2035”). However, the DWWSP now is scheduled to be completed, and to be ready for testing, on June 1, 2016, while the joint intake facility may not be completed until as late as October 28, 2016.

For this reason, WDCWA needs to temporarily pump water from the RD 2035 Main Canal into the DWWSP raw-water pipeline and to convey that water to the DWWSP Regional Water Treatment Facility, so that testing of that facility may proceed on schedule and so that WDCWA then can start operating the DWWSP to supply treated water to the Cities of Woodland and Davis and the University of California, Davis.

If the test and startup of the DWWSP were to be delayed, then the following adverse consequences would occur: Many of the citizens of Woodland and Davis, who funded the DWWSP through water rates, would receive drinking water from wells that would not meet the current hexavalent chromium drinking water standard. Also both cities have hard water that corrodes appliances and plumbing, leading to expensive maintenance or replacements. Some citizens install water softeners to address these hard water concerns. These water softeners cost money to operate and maintain and the byproducts of the water softeners add more salt to the cities’ wastewater, which is already high in salinity. The high mineral content of the well water also causes customer dissatisfaction in the taste of the water. For citizens who have seen a dramatic increase in their water rates, a dramatic improvement in taste of the water is expected. The delay would also impose additional financial hardship on WDCWA to pay the Design-Build Operator for continued mobilization of staff and temporary construction facilities while the delay is in effect.

WDCWA must make a large financial investment for the rental of the temporary piping and pumping equipment on or before April 1, 2016. WDCWA therefore is requesting the SWRCB to approve the TUCP on or before April 1, 2016, before WDCWA makes this large financial investment.

There are no other diversions between the present point of diversion and the proposed point of diversion, so the temporary change will not result in the injury to any other legal user of water.

For the reasons discussed in the attached DWWSP EIR Addendum No. 8, which WDCWA approved on November 24, 2015, the requested change will not have any unreasonable effects on fish, wildlife or instream uses. On November 16, 2015, Dennis Diemer, WDCWA’s General Manager, Lindsay Smith of West Yost Associates, Erich Fischer of Environmental Science Associates, Mary Lisa Lynch of the California Department of Fish and Wildlife (CDFW)), and Michelle Coldiron of CDFW met to discuss this proposed temporary urgency change. Following that meeting, CDFW’s representatives advised WDCWA’s representatives that CDFW will not oppose this petition if the pumping that will be authorized by the order granting the petition begins on or after June 1, 2016.



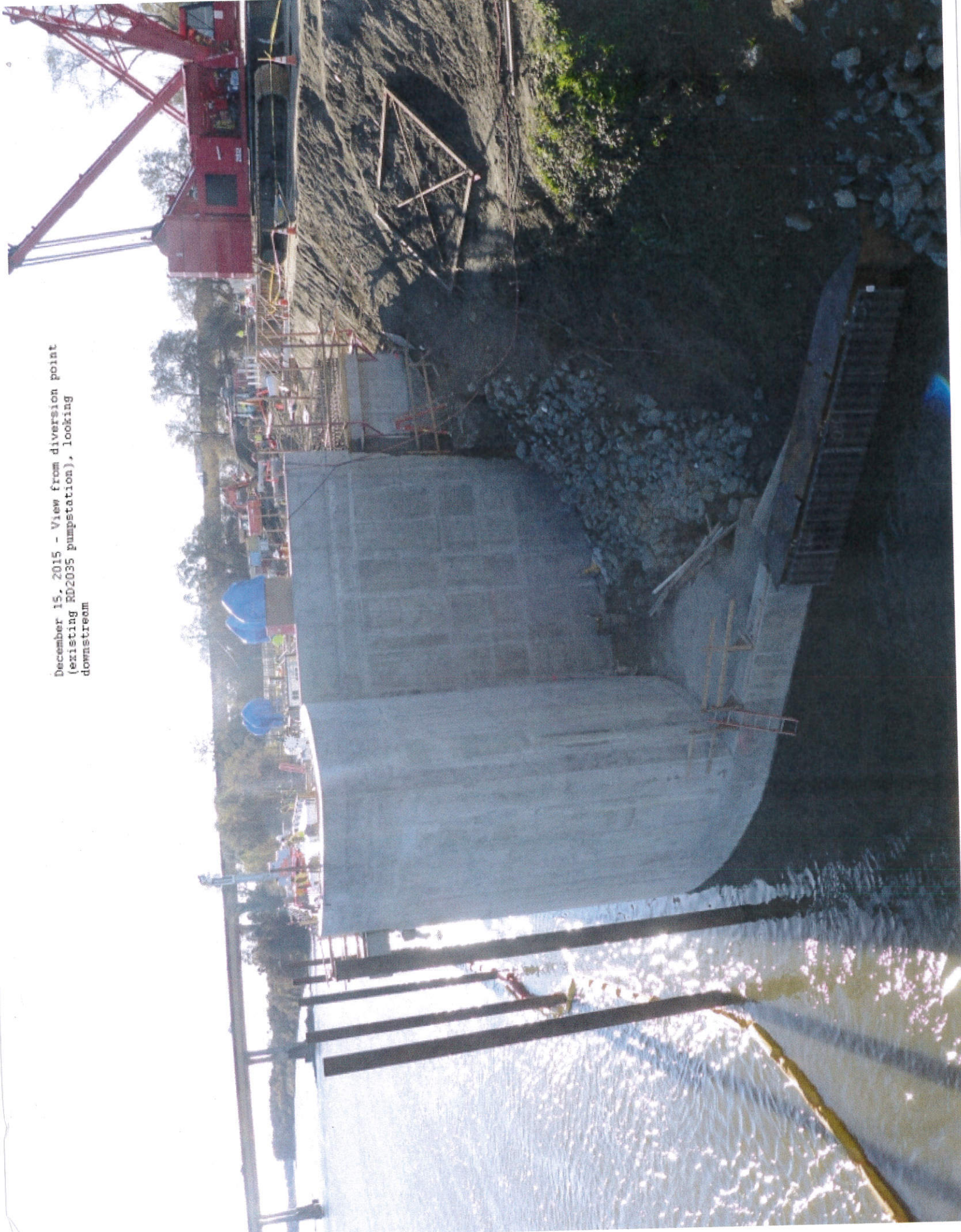
### **Attachment 3 (Description of Proposed Changes)**

If this petition is granted, then WDCWA will install a temporary pump station at the WDCWA/RD 2035 joint intake site to divert water from the RD 2035 Main Canal and deliver this water to the DWWSP raw-water pipeline. These activities are described in detail, with illustrative figures, in the attached DWWSP EIR Addendum No. 8, which WDCWA approved on November 24, 2015.

WDCWA has obtained all necessary permits for the DWWSP and no additional permits are required for the activities associated with this change petition.

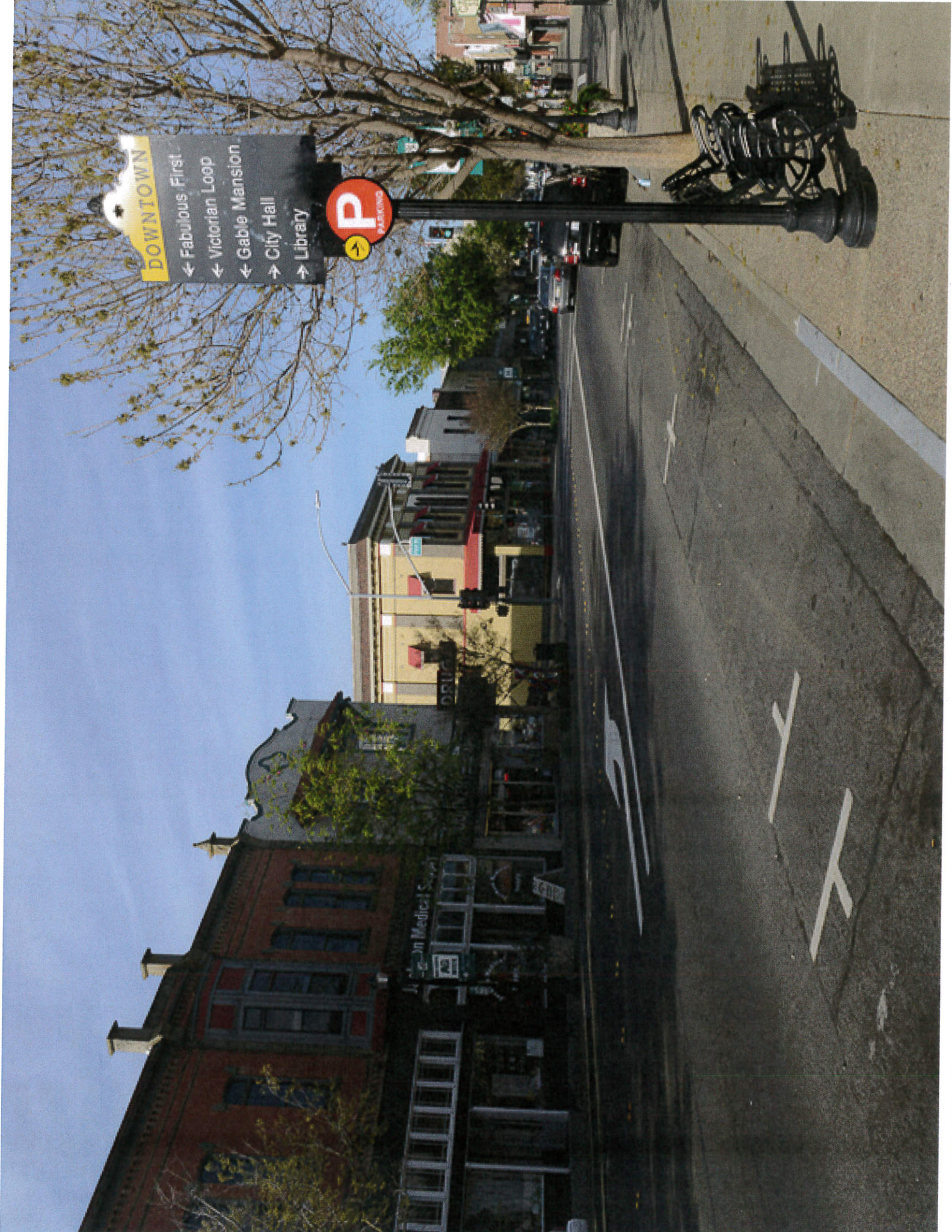
December 15, 2015 - View from diversion point
