**ORDER**

Treated Wastewater Change Petition WW-23

**ORDER APPROVING CHANGE IN PLACE OF USE AND  
PURPOSE OF USE OF TREATED WASTEWATER**

**WHEREAS:**

1. Treated Wastewater change petition WW-23 was filed by the Running Springs Water District on December 6, 1993 pursuant to Sections 1210 and 1211 of the California Water Code.
2. The change petition was filed with the State Water Resources Control Board (SWRCB) to obtain approval under Sections 1211 and 1700 of the California Water Code to change the place of use and purpose of use of treated wastewater discharged from the Running Springs Wastewater Treatment Plant in San Bernardino County.
3. The Lahontan Regional Water Quality Control Board, a Responsible Agency under CEQA, adopted Board Order No. 6-94-84 for new water reclamation requirements for Running Springs Water District and the Snow Valley Ski Resort. The Regional Water Quality Control Board limited the project by approving irrigation, but denied the snow-making process.
4. The SWRCB has determined that good cause for the change has been shown.
5. The SWRCB has determined that the change does not constitute the initiation of a new right nor operate to the injury of any other lawful user of water.

**NOW, THEREFORE, IT IS ORDERED THAT:**

1. The source of treated wastewater is the Running Springs Wastewater Treatment Plant in San Bernardino County located within the SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 6, T1N, R2W, SBB&M. California Coordinate System, Zone 5, North 253,900 and East 2,261,250. (0000001)

2. The purpose of use shall be Irrigation. (0000003)

3. The place of use shall be 300 net acres within the 600 acre Snow Valley Ski Resort, described as follows:

within the SE¼ of Section 25, T2N, R2W, SBB&M;  
within the SW¼ of Section 30, T2N, R1W, SBB&M;  
within the NW¼ of Section 31, T2N, R1W, SBB&M;  
within the NE¼ of Section 1, T1N, R2W, SBB&M;  
within the NW¼ of Section 6, T1N, R1W, SBB&M; and  
within Section 36, T2N, R2W, SBB&M.

4. The season of use shall be April 16 to December 14.

5. The two locations identified in the Running Springs Advanced Wastewater Treatment and reclamation Project Final EIR/EIS that could not be surveyed for cultural resources, due to dense vegetation, shall be surveyed by a professional archeologist after the initial clearing of vegetation. A professional archeologist shall be present to monitor the pipeline trench excavation within the Fredalba section of Running Springs. If any cultural resources are identified during the above noted activities or during any other project aspects, all ground disturbing activities shall cease within 100 feet of the discovery until the feature(s) are examined by a professional archeologist and appropriate mitigation measures are completed.
