**RE: Request for Extension of Time to File and Serve Objections in
Hearing on California WaterFix Water Rights Change Petition**

Dear Hearing Chair Doduc and Hearing Officer Marcus:

This firm represents several protestants in the above-referenced petition.¹ We respectfully join in the request by AquAlliance and others for at least a 27 -day extension of time in the Hearing on the WaterFix Change Petition for the filing and service of written objections concerning the petitioners' case in chief.

I have reviewed the letter submitted by Petitioners DWR and BOR on Friday June 3rd. The letter does not recognize that the Petitioners' case in chief will begin *after* the presentation of policy statements. While it is unclear exactly how long the policy statements will take, petitioners will have more than two weeks to review and appropriately respond to evidentiary objections. Additionally, the release of different sets of voluminous modeling data over the past year has *impaired, not assisted*, in the ability of protestants to expeditiously analyze the manner in which the proposed water right changes will harm other legal users of water, and to consider effects on fish and wildlife. Now protestants must sort through all of this information to determine what parts are relevant to the proposed change; adequate time should be afforded for this endeavor.
