Subject: Update - Public Records Act Request for Ex Parte Correspondence about the Change Petition since 26 August 2015

To: Dana Heinrich, Attorney, SWRCB

On Friday, 17 October 2017, while contacting the CWF Team, to ensure that my Patrick Porgans/Associates NOI and Statement of Service successfully uploaded to the SWRCB' FTP site. At that time, the **Team Member explained to me that you apologize for the delay**, in providing the documents requested in Patrick Porgans/Associates (P/A) **Public Records Act (PRA)** request, which was **submitted on Friday, 1 September 2017**.

On 3 October 2017, you sent me an email, which states: *I apologize for the delay in processing your request. We had some technical difficulties with our Outlook search, which had to be resolved by our Division of Information Technology. Also, we have had to review over 5,000 emails to determine if any of them are*

within the scope of your request. We have almost completed our review, and so far we have identified approximately 100 or 200 responsive emails.

“... but barring unforeseen circumstances, I anticipate being able to get them to you sometime during the latter half of next week.”

P/A explained to the CWF Team member that we appreciate your efforts to date. Due to the extended period that has elapsed (75 days), as a good-faith gesture, P/A would appreciate receiving those records identified, approximately 100 or 200 responsive emails, before the CALIFORNIA WATERFIX HEARING – PART 2 PRE-HEARING CONFERENCE, scheduled for Thursday, 19 October 2017. This will allow the Department a little more time to complete processing the remainder of P/As Public Records Act request. Thank you.
