Dear Hearing Officer Doduc and Hearing Officer Marcus,

There is currently considerably uncertainty in the surrebuttal hearing schedule, and about what parties will be testifying when the hearing commences on September 26, 2018. California Water Research has two witnesses who have to travel long distances for the hearing. Deirdre Des Jardins, principal at California Water Research ("California Water Research") is therefore respectfully requesting that the Hearing Officers clarify the surrebuttal hearing schedule prior to tomorrow's hearing date.

With respect to the schedule for DWR's witnesses to testify, the September 18, 2018 Hearing Ruling states:

Petitioners are further directed to make the testifying witness(es) available for questioning by CCLP during the sur-rebuttal phase of the hearing. Questions will be strictly limited to issues relating to potential impacts to CCLP's water rights from the WaterFix Project. CCLP had an adequate opportunity to cross-examine Petitioners' witnesses about issues not specific to CCLP's water rights, and other parties with similar interests had the opportunity to explore those topics in detail. Several of the questions submitted in writing by CCLP on August 9, 2018, will not be allowed on cross-examination of Petitioners' witness(es), unless CCLP can demonstrate that the questions are intended to elicit testimony that directly relate to CCLP's water rights. Petitioners' witness(es) will be scheduled to appear on a date falling within the sur-rebuttal phase of the hearing that we will announce shortly.

California Water Research respectfully requests that the Hearing Officers specify the date on which DWR's witnesses will be testifying. California Water Research also requests that the Hearing Officers rule on the requests to change order of proceeding.
