### **INSPECTION REPORT, INFORMATION ORDER WR 2022-0172-DWR – SCOTT RIVER WATERSHED – SISKIYOU COUNTY**

Enclosed is an Inspection Report, Information Order WR 2022-0172-DWR (including an Information Order Response Form)

#### **INFORMATION ORDER WR 2022-0172-DWR**

The enclosed Information Order requires submittal of information regarding water use in the Scott River watershed, specifically for surface water and groundwater diversion and use on the parcel(s) APNs 024-160-390-000, 024-130-170-000, and 024-130-030-000 associated with Water Right IDs S000774, S019640, and SG003207 that are owned by DAVID COLLENBERG (or his successor in interest). Addendum 35 to Order No. WR 2021-0083-DWR and Order No. WR 2021-0084-DWR curtailed all surface water rights and groundwater extraction (with limited exceptions) on July 14, 2022. It remains in effect until further notice. You hold water right ID(s) S000774, S019640, and SG003207 which are curtailed in accordance with these orders.

**You are receiving this letter as the owner of record for the land parcel(s) listed in Attachment A.**

### **Emergency Regulation**

On August 17, 2021, the State Water Board adopted an emergency regulation establishing drought emergency minimum flows in the Scott River and Shasta River watersheds (hereinafter “Regulation” or “Emergency Regulation”). (Cal. Code Regs., tit. 23, §§ 875-875.9.) The Regulation was reviewed and approved by the Office of Administrative Law and went into effect upon filing with the Secretary of State on August 30, 2021. The State Water Board readopted the Regulation with amendments on June 21, 2022, with Resolution No. 2022-0025. The Regulation was reviewed and approved by the Office of Administrative Law and went into effect upon filing with the Secretary of State on July 20, 2021. The current [regulation](#) is available online.

### **Information Order**

The primary purpose of this Order is to provide the State Water Board with water use information. Data collected under information orders is used to assess compliance with the emergency regulations.

Under the Regulation (specifically Section 875.8), the Deputy Director may issue information orders to landowners, diverters, or other water right holders in the Scott River and Shasta River watersheds, requiring them to provide additional information related to water use as relevant to implementing the Regulation.

### **Required Response – Information Order Form**

Within 14 calendar days of issuance of this Order, you or your agent is required to complete the enclosed Information Order Form providing information on your water use. **Timely and accurate completion of the required form can help you avoid enforcement proceedings. ### **Potential Enforcement**

The enclosed Order includes enforceable requirements regarding information for a water right or claim of right that require your immediate attention. Diverting water in violation of the enclosed Order or the Regulation risks administrative fines, or prosecution in court. The State Water Board has enforcement discretion and decisions related to enforcement and associated penalties are based on the specific circumstances of the violation. Fines may be up to \$500 per day of violation. (Section 875.9.)

### **Request for Reconsideration**

You may submit a petition within 30 days to request that the State Water Board reconsider the enclosed Order. The process and grounds for reconsideration are

provided by California Code of Regulations, title 23, sections 768 through 771. Any petition requesting reconsideration must be filed with the State Water Board no later than **November 13, 2022**. To ensure timely consideration, any petition for reconsideration should be emailed to:

**FINDINGS:**

1. On August 30, 2021, an emergency regulation, titled Establishment of Minimum Instream Flow Requirements, Curtailment Authority, and Information Order Authority in the Klamath River Watershed (hereinafter “Regulation” or “Emergency Regulation”) went into effect. The State Water Board readopted the Regulation with amendments on June 21, 2022, with Resolution No. 2022-0025, which are now in effect after review and approval by the Office of Administrative Law. The Regulation provides curtailment authority throughout the Klamath River Watershed and establishes minimum instream flow requirements and information order authority in the Scott River and Shasta River watersheds.
2. Under the Emergency Regulation, the Deputy Director for the Division of Water Rights may issue an information order to some or all landowners in the Scott River and Shasta River watersheds, requiring them to provide information related to diversion and use of water relevant to implementing the regulation. (Cal. Code Regs., tit. 23, sec. 875.8.)
3. The primary purpose of this Order is to collect information regarding water use in the Scott River watershed to assess compliance with the emergency regulations.
4. This information is otherwise not readily obtainable because it depends on knowledge of water use on various land parcels.
5. The Division of Water Rights has created the Scott River Watershed Water Use Information Form which is attached to this Order. The form shall be completed and returned by post to the address or email below:

6. Submittal of the Form is required within fourteen (14) days from the effective date of this Order. Timely reporting will allow the State Water Board to process the information efficiently during this drought emergency. The Deputy Director may grant additional time for the submission of information regarding water use upon a showing of good cause. Each recipient of this Order is responsible for immediately providing notice of any information order(s) to any or all agents, successors in interest, grantees, and assigns thereto required to provide complete information.

**IT IS HEREBY ORDERED:**

1. This Information Order shall be effective on October 14, 2022.
2. By October 28, 2022, each recipient of this Order who diverts water for use on their land parcel(s) shall submit, under penalty of perjury, the information described in this paragraph. Each recipient of this Order must provide the following information on each water source serving their parcel(s) or used to provide water supply from **July 2, 2022 through the date of receiving this Information Order:**
  - I. Information on all Surface Water Points of Diversion
    - a. For each surface water point of diversion:
      - i. Date(s) water was diverted;
      - ii. Quantity of water diverted;
      - iii. Quantity of water used for (1) irrigation, (2) livestock watering, (3) human health and safety, (4) diverted to storage;
      - iv. Diversion maximum flow rate; and
      - v. Capacity of reservoir/sump in acre feet.
  - II. Information on all Groundwater Points of Diversion
    - a. Coordinates identifying the location of each groundwater well for which you have not already filed an Initial Statement of Diversion and Use;
    - b. The current maximum flow rate of each well;
    - c. For each date the wells operated:
      - i. Quantity of water diverted;
      - ii. Quantity of water used for (1) irrigation, (2) livestock watering, (3) human health and safety, (4) diverted to storage; and
      - iii. Diversion maximum flow rate.
    - d. For irrigated acres from July 2, 2022 through date of receiving this Information Order:

- i. The parcel(s) where irrigation has occurred;
  - ii. Date(s) of irrigation on each field;
  - iii. Source(s) of water for irrigation;
  - iv. Number of irrigated acres per crop type; and,
  - v. Amount of water used for irrigation on each field.
3. The Division may follow-up with additional information requests pursuant to this Order if necessary to clarify or complete the initial information request and response as necessary.
4. Violation of this Order shall be subject to enforcement and any applicable penalties pursuant to Water Code section 1846.
5. Nothing in this Order is intended to or shall be construed to limit or preclude the State Water Board from exercising its authority under any statute, regulation, ordinance, or other law, including but not limited to, the authority to bring enforcement against diverters for unauthorized diversion or use in violation of Water Code section 1052.
6. Nothing in this Order shall excuse individual water right holders from meeting any more stringent requirements that may be imposed by applicable legally binding legislation, regulations, or a water right permit requirement. This Order does not authorize any act which results in the taking of a threatened, endangered, or candidate species or any act which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish and Game Code sections 2050 to 2097) or the federal Endangered Species Act (16 U.S.C.A sections 1531 to 1544).

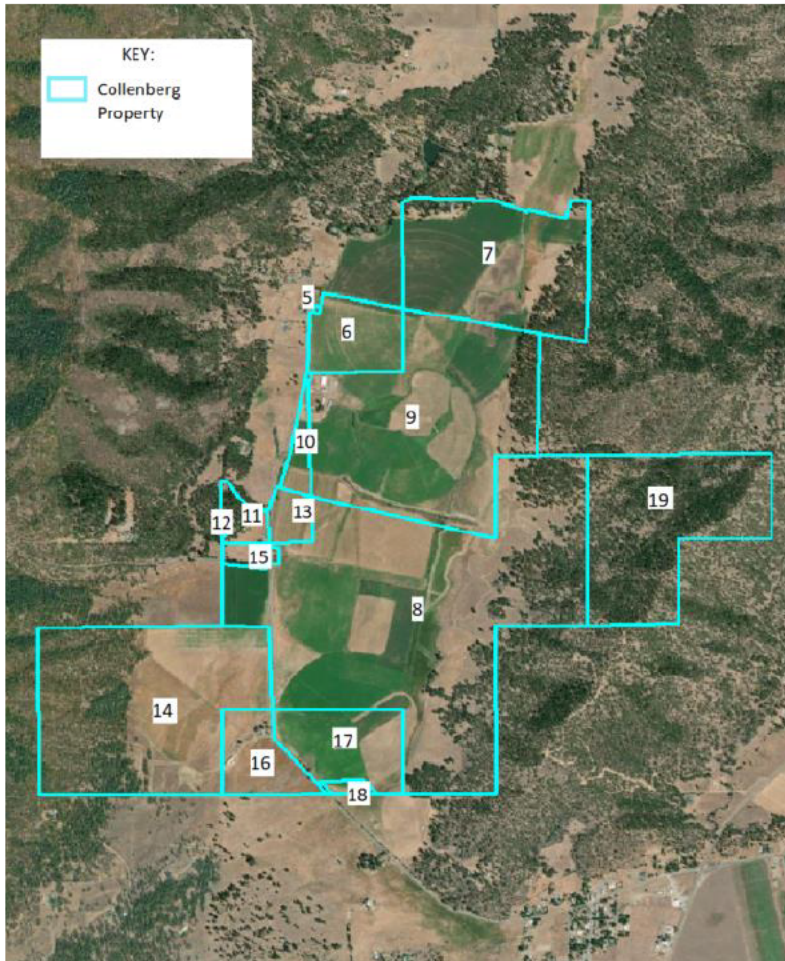
