### WITHDRAWAL OF THE DRAFT CEASE AND DESIST ORDER AGAINST ENI MENCONI TRUST - PARCELS 189-22-017 AND 189-22-019

The State Water Resources Control Board (State Water Board), Division of Water Rights (Division) has received and reviewed your letters of March 22, 2010 and April 15, 2011. These letters provide additional information regarding the claimed riparian status of the Eni Menconi Trust (Menconi Trust) property. You believe this additional information is sufficient to resolve the issue and for the Division to dismiss the draft Cease and Desist Order (CDO) dated January 28, 2009.

To withdraw the draft CDO and support cancellation of the pending hearing, the Division's Prosecution Team needs evidence supporting a valid basis of right for Menconi Trust property that was not available when the draft CDO was issued.

Staff of the Division's Prosecution Team recently re-evaluated all available information pertinent to this case in light of the recent Delta Hearing Proceedings and your submittals. Clarifications resulting from those hearings indicate that riparian rights may be preserved if there is sufficient evidence demonstrating that a grantor of a property intended to convey the rights to a grantee. Viewing of the facts of your case in light of the hearing proceedings supports a conclusion that there was sufficient intent to preserve the riparian rights within the Williams' family. Those rights were later conveyed to the Menconi property through Indenture.

The Division's Prosecution Team concludes that as a result of the 1889 Decree in Partition, the Williams Ranch property was contiguous to Middle River and therefore would enjoy a riparian right to the natural flow of Middle River. Based on subsequent indentures, the Division's Prosecution Team concludes that a riparian right to the natural flow of Middle River was preserved for Menconi's property, initially through the transfer and distribution of Thomas Williams' Sr. estate and subsequently by the continuous physical connection of the subsequent properties to Middle River. Based on this information, the Division's Prosecution Team concludes that a riparian right to the natural flow of Middle River exists for the Menconi Trust property. The Delta Watermaster has reviewed the documents for this matter and concurs with this finding. The Division also acknowledges the Menconi Trust Statement of Water Diversion and Use.

The Division's Prosecution Team hereby withdraws the draft CDO dated January 28, 2009. By copy of this letter, the hearing team is advised that the draft CDO is withdrawn and that the Division's Prosecution Team does not intend to go forward with any prosecution of this action. The Prosecution Team has not made a finding as to any pre-1914 right claimed by the Menconi Trust, or the availability of natural flow in Middle River.
