SUBJECT OF THE CANCELLED HEARING

The State Water Resources Control Board (State Water Board or board) scheduled a hearing to receive evidence relevant to determining whether to adopt, with or without revision, a draft cease and desist order (CDO) against Gallo Vineyards, Inc.


Subsequently, Gallo Vineyards, Inc. and the Division of Water Rights' Prosecution Team reached a settlement agreement and requested postponement of the hearing. By Notice of Postponement of Public Hearing, dated March 29, 2010, the State Water Board postponed the May 5th hearing. On July 2, 2010, the State Water Board's Executive Director issued Water Right Order WR 2010-0026-EXEC (Order Approving Settlement Agreement). Accordingly, no hearing is required to be held on the adoption of the proposed CDO and the previously postponed hearing is cancelled.
