## ORDER CHANGING THE EFFECTIVE DATE OF LONG-TERM INSTREAM FLOW REQUIREMENTS

By transmittal cover letter dated February 24, 2006, you were notified that the draft order regarding Yuba County Water Agency's (YCWA) Petition to Change the effective date of the long-term instream flows requirements of Revised Decision 1644 (RD-1644) would be scheduled for consideration at the State Water Resources Control Board (State Water Board) meeting on March 22, 2006. The purpose of this letter is to notify you that the State Water Board has cancelled its March 22, 2006 meeting. The draft order will now be scheduled for consideration at the State Water Board's **April 5, 2006** meeting. Parties should submit in writing any comments or changes to the proposed order they would like the State Water Board to consider at the meeting and serve copies of the comments on all other parties to the hearing.
