Ladies and Gentlemen:

Board Member Sean Maguire will not serve as the new hearing officer for the Douglas and Heidi Cole and Marble Mountain Ranch hearing. At 3:41 PM yesterday, the Prosecution Team attorney, Ken Petruzzelli, orally disclosed that Mr. Maguire may have briefly participated in enforcement strategy discussions in his previous role as a program manager within the Division of Water Rights. This disqualifies him from serving as the hearing officer.

Hearing team members have not communicated with Mr. Maguire regarding any substantive or controversial procedural matters within the scope of the proceeding. Parties to the hearing shall have 10 days to request an opportunity to comment on the communication from Mr. Petruzzelli.
