- 3:00 PM Meet at the intersection of Highway 76 and Interstate 15. Meet on the south side of Highway 76 immediately east of Interstate 15.
- 3:15 PM Travel east on Highway 76 to the Monserate Narrows. View western edge of Pala Basin and locations of Applications 30038 and 30374.
- 3:45 PM Continue east on Highway 76 to the town of Pala. Stop for refreshments and view the central portion of the Pala Basin.
- 4:15 PM View the boundary of the Pala and Pauma Basins immediately east of Frey Creek.
- 4:45 PM Drive northeast up Nate Harrison Grade for an overview of the central portion of the Pauma Basin and locations of Applications 30160, 30165, 30175, 30178, and 30355.
- 5:15 PM Travel southeast on Highway 76 toward the town of Rincon. View the eastern end of the Pauma Basin and the locations of Applications 30083, 30160, and 30260.
- 5:30 PM Conclude field tour.
