Ladies and Gentlemen:

In accordance with the attached [Settlement Agreement](#) titled "Agreement to Encourage Collaboration and Improve Water Management" (Agreement), the State Water Board's Division of Water Rights Prosecution Team (Division Prosecution Team), Woods Irrigation Company, and other parties including Landowners Who Receive Irrigation Water From Woods Irrigation Company (Group A and Group B), South Delta Water Agency, State Water Contractors, and San Luis and Delta Mendota Water Contractors (hereafter collectively referred to as Parties) have agreed to settle this matter in lieu of proceeding to a supplemental hearing. The supplemental hearing was postponed by [Notice of Postponement of Public Hearing](#), dated April 22, 2015.

Pursuant to the November 10, 2014, [Notice of Supplemental Public Hearing and Pre-Hearing Conference](#), "...all parties will be given the opportunity to comment on any settlement submitted to the State Water Board or the Executive Director for approval."
