NOTICE OF PETITION FOR TIME EXTENSION FOR WATER RIGHT PERMIT 15379 (APPLICATION 22551) OF CITY OF YREKA

COUNTY: Siskiyou

STREAM SYSTEM: Klamath River

On January 6, 2023, the City of Yreka (City) filed a petition for extension of time for water right Permit 15379 (Application 22551) with the State Water Resources Control Board, Division of Water Rights (Division). On December 12, 2023, the City made amendments to the petition for extension of time. A summary of Permit 15379 and the change requested with the petition follows.

Summary of Permit 15379 and Proposed Change:

Sources:

- 1) an Unnamed Stream tributary to Fall Creek thence Klamath River
- 2) Fall Creek tributary to Klamath River

Points of Diversion:

- 1) SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 30, T48N, R4W, Mount Diablo Base and Meridian (MDB&M);
- 2) SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 25, T48N, R5W, MDB&M

Point of Rediversion:

SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 30, T48N, R4W, MDB&M

Season of Diversion:

January 1 to December 31 of each year

Amount of Water:

Direct diversion of 15 cubic feet per second with a maximum annual limitation of 6,300 acre-feet per year

Purposes of Use:

Municipal, Domestic, and Industrial

Places of Use:

Within the City's service area boundary which is a gross 5,490 acres within Sections 7, 18, and 19, T45N, R6W, MDB&M; Sections 12, 13, 14, 15, 16, 21, 22, 23, 24, 25, 26, 27, 28, 33, 34, and 35, T45N, R7W, MDB&M; and Sections 3 and 4, T44N, R7W, MDB&M; as shown on map dated March 2012.

Time to Complete Construction and Beneficial Use:

Existing: December 31, 2022

Extension Requested with Petition: December 31, 2043

Pursuant to California Water Code section 1703.1, any interested person may file a protest to the proposed change. Protests filed in response to this notice should be submitted to the persons listed below and must be received by the Division on **March 11, 2024**. Protests may be provided via email prior to the deadline; however, a copy of the original signed letter of protest must be subsequently filed with the Division.
