Project Title: Florence Lake Dam Geomembrane Installation and Infrastructure Repair Project (Project)

Project Location - Specific: The Project area is located in the Sierra Nevada mountain range, approximately 80 miles east of the city of Fresno. The Project is located on the South Fork San Joaquin River, within the Sierra National Forest, in Fresno County, California.

Project Location - County: Fresno

Description of Nature, Purpose, and Beneficiaries of Project: Florence Lake is part of Southern California Edison's (SCE) Big Creek 2A, 8, and Eastwood Hydroelectric Project, Federal Energy Regulatory Commission (FERC) Project Number 67, for which FERC issued an operating license on August 9, 1978. SCE proposes to install a geomembrane liner on two sections of the Florence Lake Dam. In addition to the geomembrane installation, repairs to the plinth, low-level outlet structure, slide gates, and Ward Tunnel intake will be undertaken. Maintenance of the Ward Tunnel minimum pool weir will be conducted as needed.
