#### PLEASE TAKE NOTICE

The **Public Hearing** formerly scheduled to commence on **March 29, 2019**, as identified in the **February 5, 2019 Notice of Public Hearing**, is **cancelled**.

On October 19, 2018, the State Water Resources Control Board (State Water Board) Division of Water Rights issued Administrative Civil Liability Complaints against Richard Jennings (Respondent) for the alleged violation of annual water use reporting requirements. The State Water Board scheduled a hearing at the request of the Respondent to receive evidence relevant to determining whether the Respondent violated regulations or the terms or conditions of any permit or license requiring the filing of a Progress Report by Permittee or Report of Licensee and, if a violation occurred, to determine the amount of administrative civil liability and adopt an order imposing civil liability upon the Respondent.


On March 21, 2019, the Respondent and the Prosecution Team jointly requested postponement of this hearing pending completion of settlement negotiations. On March 22, 2019, the Hearing Officer granted the request for postponement. The Prosecution Team and the Respondent executed a settlement agreement. On July 23, 2019, the State Water Board's Executive Director issued Order WR 2019-0048-EXEC, approving this settlement agreement. Accordingly, no hearing is required to be held on this matter, and the hearing is **hereby cancelled**.
