ORDER R5-2018-0091

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds that the Central Valley Water Board adopted the following Orders which are no longer applicable for the reasons shown:

a. **EVERGREEN LODGE DESTINATION HOLDINGS, LLC, EVERGREEN LODGE WASTEWATER TREATMENT FACILITY (FACILITY)**

Waste Discharge Requirements Order 5-00-132, adopted on 16 June 2000, prescribes requirements for the discharge of wastewater from the Evergreen Lodge Wastewater Treatment Facility (Facility) located at 33160 Evergreen Road, Groveland in Tuolumne County, approximately 20 miles east of Groveland, and five miles north of Highway 120. The Facility is owned and operated by Evergreen Lodge Destination Holdings LLC. (Discharger). On 25 October 2017, the Discharger submitted Facility documents and a Form 200. The documents indicated the Facility treats domestic wastewater from 88 guest cabins, 16 tent campgrounds, a restaurant, a tavern, a general store, a swimming pool, a commercial and staff laundry, an onsite staff housing, and a staff cafeteria. The annual average wastewater flow is roughly 8,733 gallons per day. The Facility utilizes 40 septic tanks, two grease traps and 5,500 linear feet of leach field. Central Valley Regional Water Quality Control Board staff determined that the Facility can be regulated under State Water Resources Control Board General Order 2014-0153-DWQ for *General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems*. A Notice of Applicability was issued to the Discharger on 14 August 2018, assigning General Order and Monitoring and Reporting Program No. 2014-0153-DWQ-R5272 to the Facility. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 5-00-132.

b. **MATTHEWS READYMIX VANCE AVENUE PIT, BUTTE COUNTY**

Mathews Readymix Vance Avenue Pit, Waste Discharge Requirements Order 97-253, adopted on 5 December 1997 prescribes requirements for the Vance Avenue Pit gravel washing facility, Butte County (Site). Gravel washing and washwater disposal activities ceased at the Site in 1993 and the facility did not operate under this Order. The owner does not plan to resume operations in the future. Therefore, WDR Order 97-253 is no longer required.

c. **U.S. AIR FORCE, BEALE AIR FORCE BASE, YUBA COUNTY**

Waste Discharge Requirements Order R5-2007-0044, adopted on 4 May 2007, prescribes requirements for discharge of sodium lactate as a treatment enhancing substance to remediate volatile organics in groundwater at Site 31, Beale Air Force Base in Yuba County. The enhanced in-situ bioremediation system, constructed as an interim groundwater remedy, operated from 2007 to 2010 with subsequent injections performed in the source area in 2010 and 2011. Regulation of future discharges for in-situ groundwater remediation was enrolled for coverage under General Order No. R5-2015-0012-045 on 27 September 2018. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2007-0044.

IT IS HEREBY ORDERED that the above Orders are rescinded on the date of this order unless otherwise stated above.
