To: Public Water Purveyors

Pursuant to Water Code Section 13272.1, we are transmitting the enclosed Quarterly Report (October 1 - December 31, 2003) to all public water system operators within the boundaries of the Lahontan Regional Water Quality Control Board.

The report lists discharges of MTBE (methyl tertiary-butyl ether) and locations where MTBE was detected in either ground water or surface waters. The report is organized by county and includes the name and address of the site and indicates whether MTBE was discharged and/or detected in either groundwater or surface waters. The column entitled "MTBE Discharge" applies to confirmed discharges of MTBE and the column entitled "MTBE Groundwater Detection" applies to locations where MTBE has been detected in the groundwater.

This report contains the complete list of MTBE discharge sites that are known to the Regional Board. Please be advised that this report only contains information that we are aware of that is currently in our database. There is a possibility that a site with an MTBE discharge and/or with groundwater detection may not be listed in this report.

On a quarterly basis you will be provided with an updated list of confirmed MTBE discharges and the locations where MTBE was detected in groundwater.
