This firm represents Dairy Cares, a non-profit coalition formed by dairy farming cooperatives and other dairy-industry businesses to ensure the long-term sustainability of California's dairy farming families. As the "Community Alliance for Responsible Environmental Stewardship," Dairy Cares participated in the litigation that challenged the 2007 general waste discharge requirements for milk cow dairies. On February 2, 2018, Dairy Cares filed a response to Environmental Law Foundation's and Asociacion de Gente Unida por el Agua's Petition for Review of the Central Valley Regional Water Quality Control Board's Reissued Waste Discharge Requirements General Order for Existing Milk Cow Dairies, Order No. R5-2013-0122 (2013 General Order), SWRCB/OCC File No. A-2283(b).

Dairy Cares supports the State Water Resources Control Board's (State Board) decision to take up review of the 2013 General Order on its own motion, as set forth in the State Board's proposed order. 
