Attached is the public draft report on the impact of the 2021 TUCO and Emergency Drought Barrier on Aquatic Weeds and Harmful Algal Blooms in the Delta as required by Condition 5 of the Reconsideration of the 2021 TUCP. This report updates the report submitted on December 15th, 2021, and summarizes impacts to sub-regions of the Delta as well as analyzing the potential for disproportionate impacts to vulnerable communities.
