DISCUSSION

This non-precedential order would remand an administrative civil liability order to the Santa Ana Regional Water Board (Santa Ana Water Board), based on a stipulation and agreement between Robertson's Ready Mix and the Santa Ana Water Board. The parties agreed to reconsider and decrease the amount of economic savings in calculating the liability.

POLICY ISSUE

Should the State Water Board, upon request of the Santa Ana Water Board and the Discharger, remand an administrative civil liability order for re-calculation of the liability?

BY THE BOARD:

On August 26, 2005, the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) issued Administrative Civil Liability Order No. R8-2005-0091 (ACL) to Robertson's Ready Mix (Discharger). The Discharger timely filed a petition with State Water Resources Control Board (State Water Board) contesting the Economic Savings provision of the ACL.

The Santa Ana Water Board and the Discharger have entered into a Stipulation and Settlement Agreement jointly requesting that this matter be remanded to the Santa Ana Water Board for further proceedings, in order to consider evidence relating to the amount of Economic Savings used by the Santa Ana Water Board in assessing the ACL. By the terms of the Stipulation, the Santa Ana Water Board staff has agreed to present the additional evidence to the Santa Ana Water Board and to recommend the amount of the Economic Savings be reduced and that a revised ACL Order be issued.

The Discharger has agreed that if the Santa Ana Water Board adopts the revised ACL Order consistent with the Agreement, it will not contest the Santa Ana Water Board's revised ACL Order.

It appears that the interests of justice are served by such remand. This Order is not precedential.

ORDER

IT IS HEREBY ORDERED that the jointly requested remand is granted for further proceedings consistent with the Stipulation and Agreement between the Santa Ana Water Board and Robertson's Ready Mix.
