6. Agricultural Order 4.0 Stakeholder Panel Discussions [Chris Rose, 805/542-4770, chris.rose@waterboards.ca.gov]

Item 6 was an informational item consisting of stakeholder panel discussions on development of Agricultural Order 4.0. There were five separate panels presenting information and recommendations on regulatory oversight of agricultural discharges. The item began on Thursday morning and continued into Friday afternoon. The panelists, topics, presentations, and discussion are summarized below.

Topic: Nutrient, Irrigation and Pesticide Management

Presentation: Nutrient Management

The Board engaged the panelists during and following their presentations. Discussion topics included how to incentivize the use of groundwater nitrogen without seemingly penalizing growers for doing so; new nitrogen versus old nitrogen; identifying and following up with outliers as an approach to regulation; difficulties in tracking nitrogen removed; that some growers report low nitrogen application compared to other growers, and how they can produce a crop; using technical advisory committees to develop regulatory requirements; whether research is needed to better understand pathways of pesticides; and agricultural commissioners' role in pesticide use oversight.

Topic: Farm Management Considerations

The Board engaged the panelists during and following their presentations. Discussion topics included the conflict between regulatory requirements for vegetated riparian areas and food-safety metrics; how to give growers flexibility to reach water quality goals without micromanaging their farming operations through regulation; the requirement to minimize bare dirt; using vegetative buffers to reduce tailwater; vegetation as an attractant to rodents and other animals that are a risk to food safety; and methods to achieve water quality goals, such as sloping roads away from streams, which could be used rather than vegetation buffers.

<u>Topic: Generating Meaningful Data & Balancing Level of Detail with Reporting Burden</u> *Presentation: Agricultural Associations*

The Board engaged the panelists during and following their presentations. Discussion included tailoring nitrogen reporting to a variety of growers that can identify outliers; having a clear and understandable reporting interface; incentivizing pump and fertilize; reporting requirements that are conducive to growers' ability to accurately report; reporting nitrogen use that does not penalize groundwater nitrogen use; ability of crops to uptake nitrogen in the presence of high salts in irrigation water; continued drinking water well monitoring even after the well had a nitrate exceedance; and the role of third parties in using required data.

Environmental Advocate Panel

Topic: Water Quality Protection and How to Achieve It

The Board engaged with the panelists during and following their presentations. Discussion topics included difficulties in achieving monitoring goals where ranches have transient growers; using proxies in monitoring discharge; water quality impacts of using impermeable surfaces, such as plastic; nitrogen application limit of 150% of crop need; vegetative buffers and food safety issues; and being too prescriptive in regulatory requirements.

Creeklands Conservation for People, Ag and Wildlife Panel

Topic: Habitat Enhancement in Agricultural Land Use Areas

The Board engaged the panelist during and following her presentation. Discussion topics included beneficial use designations in areas where no fish are currently present; steelhead distribution in the region; the connection between groundwater and surface water flow; riparian habitat along agricultural landuse areas; and the fish-friendly farm program.

Discussion topics included continued monitoring of drinking water wells when an exceedance has already been discovered and replacement water is provided; timing of drinking water well testing; notification to users of contaminated drinking water wells; drinking water well contaminants other than nitrate; water board authority with respect to drinking water well testing; recent appellate court decision regarding the state board order modifying Ag Order 2.0; and quality versus quantity of reporting requirements.
