#### NOTICE OF PUBLIC HEARING

#### **Discharger and Tentative Order Information**

The City of Clovis (Discharger) is the owner and operator of the Sewage Treatment and Water Reuse Facility (Facility), a publicly owned treatment works located at 9700 East Ashlan Avenue, Clovis, California. The Facility provides sewerage services for a portion of the City of Clovis. The Facility provides tertiary treatment for an average monthly flow of up to 3.1 million gallons per day (MGD). Disinfected tertiary-treated wastewater from the Facility is discharged to any of the following sites: (1) Fancher Creek, a water of the United States; (2) the Diversion Channel, which flows to Little Dry Creek, a water of the United States; and/or (3) the City's recycled water distribution system for land application. Current and possible recycled water uses include, but are not limited to, irrigation at schools, parks, cemeteries, Fresno State agricultural fields, the Harlan Ranch development, public facilities, commercial facilities, pedestrian trails, and a portion of the Highway 168 corridor. Waste Discharge Requirements (WDRs) Order R5-2019-0021 (NPDES No. CA0085235) and the Master Recycling Permit currently regulate the discharge of disinfected tertiary-treated wastewater to the aforementioned sites.

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider the renewal of the Waste Discharge Requirements/NPDES Permit and the Master Recycling Permit for the discharge described above. In addition, the Central Valley Water Board will also consider the adoption of a new Time Schedule Order. Time Schedule Order R5-2019-0022 was adopted on 4 April 2019 and includes time schedules for the Discharger to meet final effluent limitations by 31 May 2024 for total recoverable copper, total recoverable zinc, and cyanide. The Discharger has addressed compliance for copper and zinc. However, the Discharger requested an extension for meeting the final effluent limitations for cyanide, provided information showing diligent progress towards achieving compliance, and demonstrated that additional time is needed to comply. the proposed Time Schedule Order provides an extension of the time schedule for compliance with the cyanide final effluent limitations until 31 July 2029. The proposed NPDES permit includes new or updated effluent limitations for ammonia and chronic whole effluent toxicity, and the proposed permit removes effluent limitations for copper and zinc based on updated water-effect ratios.

### Nature and Purpose of Hearing

At the hearing, the Central Valley Water Board will hear testimony and oral comments regarding the tentative Orders. This proceeding will be a formal adjudicatory proceeding. The procedures governing Central Valley Water Board adjudicatory hearings (http://www.waterboards.ca.gov/laws regulations/) may be found at California Code of Regulations, title 23, section 648 et seq. and are available upon request.

### **Prehearing Submission of Written Comments and Evidence**

The **Discharger** is a party to this proceeding. As a party, the Discharger must submit written evidence or comments, if any, for the Board to consider no later than 5:00 p.m. on 13 May 2024 to the Central Valley Water Board email at CentralValleyFresno@waterboards.ca.gov and copy Nicolette.Dentoni@waterboards.ca.gov.

**Interested persons** include any non-party that is interested in the outcome of the hearing. Interested persons wishing to comment, in writing, on the tentative Orders shall submit comments no later than 5:00 p.m. on 13 May 2024 to the Central Valley Water Board email at CentralValleyFresno@waterboards.ca.gov and copy Nicolette.Dentoni@waterboards.ca.gov.

Pursuant to California Code of Regulations, title 23, section 648.4, the Board Chair may refuse to admit written evidence or comments that are not submitted in accordance with this Notice and shall refuse to do so when there is a showing of prejudice to the Discharger or the Board. Excluded material will not be considered by the Board.

# **Requesting Party Status**

Persons who wish to participate in the hearing as a party must submit a request in writing no later than 5:00 p.m. on 22 April 2024 to the Central Valley Water Board email at CentralValleyFresno@waterboards.ca.gov and copy Nicolette.Dentoni@waterboards.ca.gov. The request must include facts demonstrating how the person will be substantially affected by the proceeding.

The Board Chair will not designate a person as a party if the Board Chair determines the designation will impair the interests of justice and the orderly and prompt conduct of the proceeding. The Board Chair, when granting a request for party status, may impose restrictions on the requestor's hearing participation, including limiting or excluding the use of cross-examination and other procedures to promote the orderly and prompt conduct of the proceeding.

### Visual Presentations

Hearing participants may use PowerPoint or other visual presentations at the hearing, but the presentation content shall not exceed the scope of previously submitted written material. Presentations, if any, must be provided to the below Central Valley Water Board Contact by 12:00 p.m. on 18 June 2024.

### Hearing Procedure and Time Limits

The hearing on the tentative Orders will be conducted in the general order listed under California Code of Regulations, title 23, section 648.5, except that the Board Chair may modify the order for good cause.

The **Discharger** will be advised in advance of the hearing of the total amount of time allocated for its presentation and closing statement. The Discharger is invited to contact staff in advance of the hearing to discuss how much time it believes is necessary.

**Interested persons** may speak at the hearing and are expected to orally summarize their written submittals, if any. Each interested person will have 3 minutes to present oral comments. Additional time may be provided, upon request, at the discretion of the Board Chair.
