The removal of vegetation or disturbance of ground surface conditions between **October 15 of any year and May 1 of the following year is prohibited**. Where it can be shown that granting a variance would not cause or contribute to the degradation of water quality, an exception to the dates stated above may be granted in writing by the Executive Officer. Dischargers are advised to complete this form and submit to the California Regional Water Quality Control Board, Lahontan Region (Water Board) to ensure that all necessary information is provided to Water Board staff in adequate time for consideration of a variance before the October 16, 2015 prohibition start date.
