### **WHAT: Onsite Wastewater Treatment Systems (Septic Systems) CEQA scoping meetings May 2 (Sacramento) May 5 (Riverside)**

The State Water Resources Control Board (State Water Board) is drafting a new policy to meet the legal mandate requiring the State Water Board to develop statewide standards for septic systems, also known as onsite wastewater treatment systems (OWTS). ### **BACKGROUND** The public CEQA policy scoping meetings deal **only** with the CEQA process.

The State Water Board will hold several public workshops later this year at yet-to-be determined locations throughout California for public comment on proposed statewide septic standards. This process is the result of feedback generated at public workshops on standards that were originally proposed in 2008. As a result of public feedback, the State Water Board went back to the drawing board with the goal of developing standards that meet the need to protect surface and groundwater quality while impacting the minimum number of OWTS owners. Although the draft proposed policy is still being developed, it is expected that the majority of OWTS owners in the state will not be affected by the new standards. These CEQA \* policy scoping meetings are part of the process, and feedback from these meetings will be considered in finalizing a draft set of standards.
