ORDER AMENDING ORDER NO. 74-155
AND ORDER NO. 76-48

TO ADOPT A REVISED COMPLIANCE TIME
SCHEDULE AND REQUIREMENTS FOR:

SANITARY DISTRICT NO. 6 OF MARIN COUNTY
NOVATO AND IGNACIO PLANTS
MARIN COUNTY

The California Regional Water Quality Control Board, San Francisco Bay Region, finds that:

1. The Regional Board on December 6, 1974 adopted Order No. 74-155 (NPDES Permit No. CA0037958) prescribing waste discharge requirements and compliance time schedules for Sanitary District No. 6 of Marin County, Novato and Ignacio Plants.
2. The Regional Board on May 4, 1976 adopted Order No. 76-48 prescribing revised waste discharge requirements and compliance time schedules for Sanitary District No. 6 of Marin County, Novato and Ignacio Plants.
3. The District is participating in the Marin - Sonoma Subregional Agency Study to comply with certain effluent and receiving water limitations, the prohibition against discharge at the present near-shore location, and the prohibition against bypass or overflow contained in Order No. 74-155. Completion of draft Environmental Impact Report/Environmental Impact Statement has been delayed due to delays in promulgation of specifications for Bay studies by the State Board and the adoption of the Marsh Policy by this Regional Board.
4. This project involves the continued operation of a publicly-owned facility to provide sewerage service with negligible or no expansion of use beyond that previously existing. Consequently, this project will not have a significant effect on the environment based upon the exemption provided in Section 15101, Title 14, California Administrative Code.
5. The Board has notified the discharger and interested agencies and persons of its intent to prescribe revised requirements for Sanitary District No. 6 of Marin County, Novato and Ignacio Plants.

6. The Board, in a public meeting, heard and considered all comments pertaining to this discharge.

IT IS HEREBY ORDERED, that the Regional Board amends Order Nos. 74-155 and 76-48 to read as follows:

Provision E.2.b.

Compliance with Effluent Limitation A.1.a., d; A.4, A.6; Receiving Water Limitations B.1.a, c; B.2.d; and Discharge Prohibition D.1. and D.2:

Provision E.9.

This Order expires on December 1, 1978, and the discharger must file a Report of Waste Discharge in accordance with Title 23, California Administrative Code, not later than 180 days in advance of such date as application for issuance of new waste discharge requirements.
