
Subject: SECOND NOTICE - Requirement to Enroll Under Industrial Storm Water General Permit, Diamond Concrete Supply, Inc.

Pursuant to California Water Code (CWC) Section 13399.30, this letter serves as your second and final notice that Diamond Concrete Supply, Inc. is required to enroll under Order No. 97-03-DWQ, National Pollutant Discharge Elimination System (NPDES) General Permit No. CAS000001, *Waste Discharge Requirements (WDRs) For Discharges of Storm Water Associated with Industrial Activities Excluding Construction Activities* (Industrial Storm Water Permit). By letter dated September 6, 2011, you were notified by the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) that coverage under the Industrial Storm Water Permit for your facility located at 6974 Mission Gorge Road in San Diego is mandatory (SIC 3273). You were also notified by the City of San Diego and San Diego Water Board inspectors, during the August 25, 2011 inspection of your facility, of the requirement to enroll under the Industrial Storm Water Permit.

You informed the inspectors that Diamond Concrete Supply, Inc. will be moving to 10124 Channel Road, Lakeside, Ca. As stated in the September 6, 2011 letter, you are required to file a Notice of Intent (NOI) for coverage of Diamond Concrete Supply, Inc., at the Lakeside facility, under the Industrial Storm Water General Permit prior to operating at the new location.

You are also required to submit a Notice of Termination (NOT) upon vacating the property at 6974 Mission Gorge Road. In order for the NOT to be approved, all of Diamond Concrete Supply's equipment and process materials must be removed from the site.

A copy of the Industrial Storm Water General Permit, including the Notice of Intent (NOI) was included in your first notice from the San Diego Water Board, dated September 6, 2011. Within thirty days, please submit a completed NOI, a site map of the facility, and the application fee of \$1008 made payable to "State Water Resources Control Board." All materials must be sent to the following address:

Failure to seek coverage could result in a mandatory minimum penalty of not less than \$5000 per year of noncompliance pursuant to CWC sections 13399.30 and 13399.33. The San Diego Water Board strongly urges you to bring your facility into compliance to avoid mandatory minimum penalties.
