## **Industrial Storm Water Inspection Report**

Facilities Visited Not Requiring Permit Coverage

Date: 2/8/2010 through 2/11/2010

Receiving Water: San Francisco Bay

Location: Various Facilities, San Leandro (Alameda County), California

## **Inspection Findings**

On February 8<sup>th</sup> through 11<sup>th</sup>, 2010, a U.S. Environmental Protection Agency (EPA) contractor, PG Environmental, LLC, and a representative from the California State Water Resources Control Board (hereafter, EPA Inspection Team) conducted door to door industrial storm water evaluations of industrial facilities in the area of Neptune Drive, Polvorosa Avenue, and Williams Street, in San Leandro (Alameda County), California. The following inspection report contains an inventory of facilities which were visited by the EPA Inspection Team but did not appear to require coverage under the California State Water Resources Control Board (SWRCB) Order No. 97-03-DWQ, National Pollutant Discharge Elimination System (NPDES), General Permit No. CAS000001 for Discharges of Storm Water Associated with Industrial Activities (the Permit). The facilities were evaluated to determine the need for Permit coverage as stated in Finding 2 of the Permit, where coverage for storm water discharges and authorized non-storm water discharges is regulated for specific categories of industrial facilities identified in Attachment 1 of the Permit.

The EPA Contract Inspector visited the following individual facilities (see Table below) and discussed the activities conducted at the each facility with the respective Facility Representative(s). Based on these discussions, the proper Standard Industrial Classification (SIC) Code for each facility was determined (see Table below). Note the EPA Contract Inspector did not conduct a Permit inspection of the facilities listed below.
