**NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND  
NOTICE OF INTENT TO ADOPT**

**Draft Statewide Conditional Waiver of Waste Discharge Requirements for Nonpoint  
Source Discharges Related to Certain Activities on National Forest  
System Lands in California**

**NOTICE IS HEREBY GIVEN** that:

1. The State Water Resources Control Board (State Water Board) is circulating for public comment a revised draft Statewide Conditional Waiver of Waste Discharge Requirements (Revised Draft Statewide Waiver) for Nonpoint Source Discharges Related to Certain Activities on National Forest System (NFS) Lands in California. **Public comments for the Revised Draft Statewide Waiver must be received by 12:00 noon on November 21, 2011. Comments shall address only revisions to the Draft Statewide Waiver reflected in redline in the documents.**
2. The State Water Board will consider adoption of the revised Draft Statewide Waiver and of a supporting Mitigated Negative Declaration (MND). The adoption meeting will be held at the following time and location:

The State Water Board provided notice of its intent to adopt the MND on June 10, 2011 and allowed an extended 76 day comment period. Limited revisions have been made to the Initial Study and MND in response to comments received. The State Water Board has determined that the revisions clarify, amplify, or make insignificant modifications to the Mitigated Negative Declaration and do not require recirculation under California Code of Regulations, title 14, section 15073.5. The revisions are expected to be posted on or about November 14, 2011, on the State Water Board program web site:

The State Water Board will not be accepting additional comments on the Initial Study/MND.

Prior to the adoption meeting, a Response to Comments on significant environmental comments received on the Draft Statewide Waiver and the Initial Study/MND will be posted on the State Water Board program web site given above.

## Background

The U.S. Department of Agriculture, U. S. Forest Service (USFS) manages the following national forests within California: Mendocino, Six Rivers, Klamath, Shasta/Trinity, Modoc, Plumas, Lassen, Tahoe, Lake Tahoe Basin Management Unit, Eldorado, Stanislaus, Sierra, Sequoia, Inyo, Cleveland, San Bernardino, Angeles, Los Padres, Rogue River-Siskiyou, and Humboldt-Toiyabe National Forests. The State Water Board is proposing adoption of a Conditional Waiver for the following activities on NFS lands statewide that could generate nonpoint source discharges: timber management, road management, range management, recreation (including off-highway vehicles), vegetation manipulation, fire suppression and fuels management, and watershed restoration.

In August 2009, the State Water Board adopted [Resolution 2009-0064](#) directing staff to work with USFS and Regional Water Quality Control Boards (Regional Water Boards) to establish a single statewide regulatory mechanism in lieu of the several Regional Water Board waivers that partially regulated activities on NFS lands. The State Water Board and USFS staff conducted a workshop to solicit public comment on November 30, 2009, and established and met several times with a multi-interest stakeholders' group. That process has resulted in the development of the Conditional Waiver and the very substantial strengthening of the USFS Water Quality Management Plan, which will be adopted as the USFS Water Quality Management Handbook (WQMH).

The Conditional Waiver covers the listed activities only to the extent that potential impacts can be reduced to less than significant through a combination of management practices specified in the WQMH, additional USFS guidance (e.g., the Watershed Improvement Program, the travel management rule, the Northwest Forest Plan, and the Sierra Nevada Forest Plan Amendments), and the conditions of the Waiver. The dominant purpose of the State Water Board action is to better maintain, protect and restore the quality and beneficial uses of water, and to clarify and facilitate USFS' compliance with water quality requirements.

The State Water Board previously circulated the Initial Study/MND and the Draft Conditional Waiver for public comment on June 5, 2011, and the public comment period closed on August 24, 2011. The State Water Board subsequently held a public workshop to receive additional comments on September 20, 2011. The MND establishes that there is no substantial evidence, in light of the whole record before the State Water Board, that the project may have a significant effect on the environment, with incorporated mitigation measures that will avoid or mitigate potential significant impacts. All of the mitigation measures needed to avoid or minimize potentially significant impacts are set out in the Initial Study/MND and have been incorporated into the Statewide Waiver's conditions. The Draft Statewide Waiver and the Initial Study/MND have both been revised in response to the comments received.

## Submission of Comments

Interested persons may submit their comments, evidence, and other material relevant to the Revised Draft Statewide Waiver by email, fax, or hard copy. In order to be fully considered, written materials and all other evidence (including photos) must be received by **12:00 noon on November 21, 2011**. **Email comments are encouraged**, but must be less than 15 MB total size. Comments shall address only revisions to the Draft Statewide Waiver as indicated in redline.


