- #2 Page v, TABLE OF CONTENTS, Chapter III. PROGRAM OF IMPLEMENTATION, add section K, information, "....", and the page number.
- #3 Page v, TABLE OF CONTENTS, Chapter III. PROGRAM OF IMPLEMENTATION, sections D through J, the page numbers 20 through 23 are incorrect. The correct page numbers are:

- #15 Page 22, section G, underline the topic for consistency.
- #16 Page 27, <u>GRAYWATER</u> definition language is not indented. Indent for consistency.
- #17 Page 52, number 11 is incorrect. The correct number is 12.
- #18 Page 55, APPENDIX VI, the topic should have all words capitalized for consistency.
- #19 Page 60, APPENDIX VIII, COASTAL MAP OF NORTHERN REGION 1, Figure VIII-1 must correspond with the map, not be located on Page 61(different map).
- #20 Page 61, COASTAL MAP OF SOUTHERN REGION 1 AND REGION 2, Figure VIII-2 must correspond with the map, not be located on Page 62(different map).
- #21 Page 62, COASTAL MAP OF NORTHERN REGION 3, Figure VIII-3 must correspond with the map, not be located on Page 63(different map).
- #22 Page 63, COATAL MAP OF SOUTHERN REGION 3 AND NORTHERN CHANNEL ISLANDS, Figure VIII-4 must correspond with the map, not be located on Page 64 by itself.
- #23 Pages 65 and 66, COASTAL MAP OF REGIONS 4, 8, AND 9 AND SOUTHERN CHANNEL ISLANDS, even though these two maps are of the aforementioned regions, there are a few differences, such as the "key", and the map on Page 66 is smaller and has the Corresponding Figure. The correct updated map of Figure VIII-5 must be consistent.

ISSUE 3 - Non Substantive Administration Changes

- #1 Page 62, it is stated under Issue Description that "Staff is proposing updates to Figure VIII-5 to reflect the correct location of Aliso Water Management Agency's ocean outfall and the newly adopted MPAs. In addition to replacing/Figure VIII-5..." Updating a map is different from replacing the document. Use "update", or "replace", not both words. Or, use the words on Fage 63, "was replaced with an updated map".
- #2 Page 62, Issue Description, first paragraph, it is stated "State Water Boards website". Change "Boards" to "Board's".
- #3 Page 62, Issue Description, second paragraph, I concur with the Tables A, B, C, and D changes to appear in alphabetical order by changing Table A to Table 2, Table B to Table 1, Table C to Table 3, and Table D to Table 4 (Page 63, Proposed Ocean Plan Amendment).
- #4 Table B also appears on Pages 33, 34, and 43. The change must also be made in these pages. Table B does not appear on Page 58 since the 2009 Ocean Plan has only 50 pages. The page number 58 does appear when the document is downloaded on the State Water Board's "Documents for Public Review" Website section.
- #5 Table C also appears on Page 41.
- #6 Page 62, Issue Description, I concur with the change of SWRCB to State Water Board(Page 63, Proposed Ocean Plan Amendment).
- #7 The change to State Water Board must also be made to Pages 2, 21, and 28.
- #8 Page 62, Issue Description, I concur with the change of RWQCB to Regional Water Board(Page 63, Proposed Ocean Plan Amendment).

- #9 The change to Regional Water Board, or Regional Water Boards must be made to Pages 10, 12, 16, 19, 20, 21, 33, and 35.
- #10 Page 62, Issue Description, I concur with changing "PH" to "pH" (Page 63, Proposed Ocean Plan Amendment).
- #11 Page 62, Issue Description, I concur with changing "M1" to "m1"(Page 63, Proposed Ocean Plan Amendment, issue not included).
- #12 Page 62, Issue Description, it is stated "The other proposed changes include: ... changing references to Chapter III(I) on pages 5 and 23 to the correct reference of Chapter III(J)". It is stated on Page 63, Proposed Ocean Plan Amendment, that "Chapter III(I) changed to Chapter III(J) on pages 23". This change was extremely difficult to agree or disagree with. Chapter III.I. Discharge Prohibitions in the 2009 Ocean Plan(Pages 22 and 23) is the same chapter in the 2011 Draft Ocean Plan (APPENDIX A, Page 24). The only difference is that the Chapter III(I) title in the 2009 Ocean Plan was separated from its numbers, and in the 2011 Draft the chapter is not separated, and the number 5. Vessels has been added. Chapter III.J. State Board Exceptions to Plan Requirements in the 2009 Ocean Plan(Page 23) is the same chapter in the 2011 Draft Ocean Plan(APPENDIX A, Page 25). Chapter III(I) was not changed to Chapter III(J).
