# DECISION APPROVING APPLICATION

The Synod of the Golden Gate of the United Presbyterian Church of the United States of America having filed Application 23661 for a permit to appropriate unappropriated water; a protest having been received; the applicant and protestant having stipulated to proceedings in lieu of hearing as provided for by Title 23, California Administrative Code, Section 737; an investigation having been made by the State Water Resources Control Board pursuant to said stipulation, the Board, having considered all available information, finds as follows:

# Substance of the Application

1. Application 23661 is for a permit to appropriate ten acre-feet per annum (afa), from Diablo Canyon (Gulch) tributary to Corralitos Creek thence Salsipuedes Creek thence Pajaro River in Santa Cruz County, by storage from November 1 of each year to April 1 of the succeeding year for irrigation, domestic, recreational and fire protection purposes. The point of diversion is to be located within the SE% of NW% of Section 24, TlOS, RLE, MDB&M, in Santa Cruz County.

### Applicant's Project

2. Applicant proposes to construct an offstream reservoir and to divert water into it from a point on Diablo Canyon (Gulch) about three-fourths of a mile upstream from its confluence with Corralitos Creek.

#### Protests

3. The City of Watsonville protested the application on the ground that the proposed diversion would interfere with appropriative, riparian and prescriptive rights held by the city. The city's intake is located on Corralitos Creek approximately three miles downstream from its confluence with Diablo Canyon (Gulch). From records kept at the city's filtration plant, the maximum diversion by the city has been about 2,400,000 gallons per day or 3.7 cubic feet per second (cfs).

#### Water Supply

4. There are two USGS gaging stations located on Corralitos Creek, one about one-half mile downstream and the other two and one-half miles downstream from the intake of the City of Watsonville.

The period of record for the upper station is from October 1957 and shows a 12-year average discharge of 9.07 cfs,

equivalent to 6,590 afa. The lower station record is from October 1956 and the 13-year average discharge is 10,140 afa. The distribution of flow at the upper station is indicated by the mean monthly flows during 1968-1969 in cubic feet per second, which were as follows:

# Availability of Unappropriated Water

5. In view of the magnitude of the flows beyond protestant's point of diversion during applicant's proposed season of diversion, the maximum historic diversion by protestant, and the comparatively small quantity of water requested by applicant, it is unnecessary to determine precisely the quantity of water to which protestant is entitled and the total quantity of unappropriated water available.

6. Unappropriated water is available to supply the applicant, and subject to suitable conditions, such water may be diverted and used in the manner proposed without causing injury to any lawful user of water.

7. The intended use is beneficial.

From the foregoing findings, the Board concludes that Application 23661 should be approved and that a permit should be issued to the applicant subject to the limitations and conditions set forth in the order following.

The records, documents, and other data relied upon in determining the matter are: Application 23661 and all relevant information on file therewith, particularly the report of field investigation made August 5, 1971.

#### ORDER

IT IS HEREBY ORDERED that Application 23661 be, and it is, approved, and that a permit be issued to the applicant subject to vested rights and to the following limitations and conditions:

1. The water appropriated shall be limited to the quantity which can be beneficially used and shall not exceed ten acrefeet per annum by storage to be collected from November 1 of each year to April 1 of the succeeding year.

2. The maximum rate of diversion to offstream storage shall not exceed 0.2 cubic foot per second.

3. This permit does not authorize collection of water to storage outside the specified season to offset evaporation and seepage losses or for any other purpose.

4. The maximum quantity herein stated may be reduced in the license if investigation warrants.

5. Actual construction work shall begin on or before nine months from date of permit and shall thereafter be prosecuted with reasonable diligence, and if not so commenced and prosecuted this permit may be revoked.

6. Said construction work shall be completed on or before December 1, 1973.

7. Complete application of the water to the proposed use shall be made on or before December 1, 1974.

8. Progress reports shall be submitted promptly by permittee when requested by the State Water Resources Control Board until license is issued.

9. All rights and privileges under this permit including method of diversion, method of use and quantity of water diverted are subject to the continuing authority of the State Water Resources Control Board in accordance with law and in the interest of the public welfare to prevent waste, unreasonable use, unreasonable method of use or unreasonable method of diversion of said water.

10. The quantity of water diverted under this permit and under any license issued pursuant thereto is subject to modification by the State Water Resources Control Board if, after notice to the permittee and an opportunity for hearing, the Board finds that such modification is necessary to meet water quality control plans which have been or hereafter may be established or modified pursuant to Division 7 of the Water Code. No action will be taken pursuant to this paragraph unless the Board finds that (1) adequate waste discharge requirements have been prescribed and are in effect with respect to all waste discharges which have any substantial effect upon water quality in the area involved, and (2) the water quality objectives cannot be achieved solely through the control of waste discharges.

11. Permittee shall allow representatives of the State Water Resources Control Board and other parties, as may be authorized from time to time by said Board, reasonable access to project works to determine compliance with the terms of this permit.

Adopted as the decision and order of the State Water Resources Control Board at a meeting duly called and held at Sacramento, California.
