ORDER CORRECTING ORDER WR 2003-0008-DWR

WHEREAS:

- 1. On February 20, 2003, Yuba County Water Agency (YCWA) filed a petition with the State Water Resources Control Board (SWRCB) requesting changes to allow the transfer of water to Contra Costa Water District (CCWD) and the Department of Water Resources (DWR). The petition requested that points of rediversion be temporarily added at Clifton Court Forebay, the Tracy Pumping Plant, the Contra Costa Canal Intake at Rock Slough, the Contra Costa Water District Los Vaqueros Project Intake at Old River, and the Contra Costa Water District Mallard Slough Intake. The public notice dated March 10, 2003 and Section 2.3 of Order WR 2002-0008-DWR identified these points of rediversion. No comments were received that raised issues concerning the use of these points of diversion. Therefore the SWRCB was prepared to approve the addition of the five points of rediversion.
- 2. Due to administrative oversight, Condition 3 of Order WR-2003-0008-DWR dated May 5, 2003, omitted the three points of rediversion o be used by CCWD.
- 3. SWRCB Resolution No. 2002-0106 Section 2.5.5 delegates to the Chief, Division of Water Rights the authority to amend or modify a decision or order to correct an obvious typographical or clerical error or oversight.

NOW, THEREFORE, IT IS ORDERED THAT:

Condition No.3 of Order WR-2003-0008-DWR is corrected to read as follows:

The Clifton Court Forebay, the Tracy Pumping Plant, the Contra Costa Canal Intake at Rock Slough, the Contra Costa Water District Los Vaqueros Project Intake at Old River, and the Contra Costa Water District Mallard Slough Intake are temporarily added as points of rediversion to YCWA's permitted Application 5632. Rediversion of water at the Clifton Court Forebay and the Tracy Pumping Plant pursuant to this Order is subject to compliance by the operators with the standards set forth in Tables 1, 2, and 3 on pages 181 to 187 of Water Right Decision 1641 and the current Water Level Response Plan as modified by SWRCB Order WR 2002-0003 or any subsequent Water Level Response Plan which provides the same or better protection for South Delta diverters, as determined by the Chief of the Division of Water Rights.
