Application WW-8 Amended Permit _____ License _____

**ORDER APPROVING CHANGE IN POINT OF DIVERSION AND
PLACE OF USE OF TREATED WASTEWATER**

WHEREAS:

1. Treated Wastewater change petition WW-8 was filed by County Sanitation Districts of Los Angeles County on November 15, 1990 pursuant to Sections 1210 and 1211 of the California Water Code.
2. The original petition was filed with the State Water Resources Control Board (SWRCB) to obtain approval under Sections 1211 and 1700 of the California Water Code to change the point of diversion, the place of use, and the purpose of use of treated wastewater. Petition WW-8 was approved by SWRCB Order dated October 4, 1991.
3. On March 15, 1993, a second Treated Wastewater change petition related to WW-8 was filed by the County Sanitation Districts of Los Angeles County pursuant to Sections 1210 and 1211 of the California Water Code.
4. The second petition was filed with the SWRCB to obtain approval under Sections 1211 and 1700 of the California Water Code to add a point of diversion and increase the place of use. The annual use would be increased by 2,800 acre-feet to a total of 5,800 acre-feet. The treated wastewater is currently discharged to the San Gabriel River tributary to Pacific Ocean, in Los Angeles County.
5. The SWRCB has determined that good cause for the change has been shown.
6. The SWRCB has determined that the change does not constitute the initiation of a new right nor operate to the injury of any other lawful user of water.


NOW, THEREFORE, IT IS ORDERED THAT:

1. This Order supersedes previous SWRCB Order dated October 4, 1991.
2. The source of the treated wastewater is the San Jose Creek Water Reclamation Plant, in Los Angeles County, which via an 8-9 mile pipeline discharges to the San Gabriel River at a location described as follows:

South 900 feet and West 2,750 feet from the NE corner of Section 11, T3S, R12W, SBB&M; being within the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of said Section. Also described as California Coordinate System, Zone 7, North 4,086,600 and East 4,255,200. (000001)
3. Location of points of diversion are described as follows:
 - A) San Jose Creek Water Reclamation Plant effluent, North 500 feet and East 2,150 feet from the SW corner of Section 34, T1S, R11W, SBB&M; being within the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of said Section. Also described as California Coordinate System, Zone 7, North 4,125,400 and East 4,281,500.
 - B) San Jose Creek Water Reclamation Plant effluent, South 2,200 feet and East 300 feet from the NW corner of Section 3, T2S, R11W, SBB&M; being within the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of said Section. Also described as California Coordinate System, Zone 7, North 4,122,750 and East 4,279,500. (000002)

4. Purpose of Use shall be: Irrigation, Dust Control, and Industrial (cooling tower). (0000003)
5. The place of use, shown on maps filed with the SWRCB, is described as follows:
 - A. The South Hills Golf Course, and South Hills High School, within projected Sections 24, 25, and 26, T1S, R10W, SBB&M;
 - B. The BKK landfill, Galaster Park, Woodgrove Park, Gingrich Park, Shadow Oak Park; and greenbelt areas within projected Sections 34, 35, and 36, T1S; and projected Sections 1, 2, 3, and 11, T2S, R10W, SBB&M; and
 - C. 400 acres within Rose Hills Memorial Park, 500 acres within the Puente Hills Landfill, and at the Puente Hill Energy Recovery Generator, within projected Sections 1, 2, 3, 4, 8, 9, 10, 11, 12, 14, 15, 16, and 17, T2S, R11W, SBB&M; as shown on a map on file with the State Water Resources Control Board. (0000004)
6. The maximum annual amount of use shall be limited to 5,800 acre-feet of treated wastewater. (0000005)

Treated Waste Water Change Petition WW-8

ORDER APPROVING ADDITION OF A POINT OF DIVERSION,
AND CHANGES IN THE PLACE AND THE PURPOSE OF USE
FOR TREATED WASTE WATER

WHEREAS:

1. Treated Waste Water change petition WW-8 was filed by County Sanitation District of Los Angeles on November 15, 1990 pursuant to Sections 1210 and 1211 of the California Water Code.
2. The change petition was filed with the State Water Resources Control Board (Board) to obtain Board approval under Sections 1211 and 1700 of the California Water Code to change the Point of Diversion, the Place of Use, and the Purpose of Use.
3. The Board had determined that good cause for the changes has been shown.
4. The Board has determined that the changes do not constitute the initiation of a new right nor operate to the injury of any other lawful user of water.

NOW, THEREFORE, IT IS ORDERED THAT:

1. The source is the San Gabriel River in Los Angeles County (0000001)
2. Point of diversion shall be described as follows:
N 4°45"E a distance of 2450' feet (plus or minus) from the northerly corner of lot 1, Section 3, T2S, R11W, SBB&M. (0000002)
3. Place of Use shall be described as follows:
Tract 4005 and Sections 3 and 10, T2S, R11W, SBB&M; as shown on map on file with the Board. (0000004)
4. Purpose of Use shall be: Irrigation, Dust Control, and Industrial (cooling tower). (0000003)
