

Two public staff workshops are scheduled for discussion related to the State Water Resources Control Board's (State Water Board) review of southern Sacramento-San Joaquin River Delta (Delta) salinity objectives included in the 2006 Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary (2006 Bay-Delta Plan).

#### SUBJECT OF WORKSHOPS

The purpose of the August 13, 2009 workshop is for Dr. Glenn Hoffman, with assistance from State Water Board staff, to present his draft study report entitled *Salt Tolerance of Crops in the Southern Sacramento-San Joaquin Delta* (Study Report) and to discuss and answer any stakeholder questions. Instructions for obtaining the draft Study Report are provided below. Written comments and questions do not need to be submitted prior to the August 13 workshop. As explained below, written comments are due on Monday, September 14, 2009 by 12 noon.

The purpose of the November 4, 2009 workshop is for Dr. Glenn Hoffman, with assistance from State Water Board staff, to discuss responses to written comments and how the comments will be addressed in the final Study Report, which will be released later in November. Instructions for submitting written comments are provided below.

At these workshops, State Water Board staff may also provide information on additional meetings regarding the review of the southern Delta salinity objectives.

#### **BACKGROUND**

In July of 2008, the State Water Board adopted a Strategic Workplan for Activities in San Francisco Bay/Sacramento-San Joaquin Delta Estuary (Bay-Delta), which identifies actions that the State Water Board, Central Valley Regional Water Quality Control Board, and San Francisco Bay Regional Water Quality Control Board will take to protect beneficial uses in the Bay-Delta. Among other activities, the Strategic Workplan calls for the review and potential amendment of the southern Delta salinity objectives together with San Joaquin River flow objectives included in the 2006 Bay-Delta Plan and their implementation.

On February 13, 2009, the State Water Board released a *Notice of Preparation and of Scoping Meeting for Environmental Documentation for the Update and Implementation of the Bay Delta Plan: Southern Delta Salinity and San Joaquin River Flows,* and the associated scoping meeting was held on March 30, 2009. Also on February 13, 2009, the State Water Board issued a notice of public staff workshop, which was subsequently held on April 22, 2009, to receive further information and conduct discussions regarding southern Delta salinity and San Joaquin River flow objectives. A follow-up staff workshop was held on June 19, 2009, to update the public on progress to date with associated San Joaquin River flow modeling. The two workshops hereby noticed are a continuation of this process as it relates to southern Delta salinity.


#### PARKING, ACCESSIBILITY, AND SECURITY
