Dear Kathy:

The referenced Petition was prepared by Janet Goldsmith and signed by a Masonite Executive V.P. on July 25, 2006. The Petition itself was inadvertently prepared on a Longterm Transfer form instead of a Change form, but the intent to permanently transfer the water right to Millview County Water District was, as you informed me, clearly stated in the Environmental Information. My understanding from Pat Meroney is that she has completed her work on the Petition and it is presently working its way through the chain of command, the abandonment/forfeiture question being the main issue, as I understand it.

Notwithstanding all of the above, there have been some changes in the attachments which accompanied the Petition and I am enclosing new revised attachments which describe the currently proposed points of diversion (Attachment 1) and place of use (Attachment 2). I am also enclosing a new up to date map showing Millview's boundaries as delineated by a licensed surveyor and the proposed place of use sought by the Masonite Petition as well as the location of the proposed points of diversion.
