# NOTICE OF PACIFIC GAS & ELECTRIC COMPANY'S PETITION FOR RECONSIDERATION OF WATER QUALITY CERTIFICATION FOR CHILI BAR HYDROELECTRIC PROJECT, FEDERAL ENERGY REGULATORY COMMISSION PROJECT NO. 2155

NOTICE IS HEREBY GIVEN THAT Pacific Gas & Electric Company (PG&E or Petitioner) has petitioned the State Water Resources Control Board (State Water Board) to reconsider the water quality certification issued, pursuant to section 401 of the Clean Water Act (33 U.S.C. § 1341), for the Chili Bar Hydroelectric Project (Project), Federal Energy Regulatory Commission (FERC) Project No. 2155. This petition was filed pursuant to California Code of Regulations, title 23, section 3867.

## **BACKGROUND**

On November 8, 2012, the State Water Board's Executive Director issued a water quality certification for the Project, which is undergoing relicensing before FERC. The Project Licensee, PG&E, filed a Petition for Reconsideration of the water quality certification for the Project dated December 6, 2012. PG&E's Petition requests reconsideration of conditions in the water quality certification related to: reservations of authority; notice and opportunity for hearing, compliance with the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins; reintroduction of anadromous fish; and climate change.
